**RESOLUTION AUTHORIZING THE EXECUTION OF A THIRD AMENDMENT WITH
FAMILY CONNECTIONS TO PROVIDE CHILD ABUSE PREVENTION
SERVICES, INCREASING FUNDING BY \$747,100 FOR A NEW TOTAL
OBLIGATION AMOUNT OF \$1,801,955, FOR THE TERM OF
OCTOBER 1, 2023 THROUGH JUNE 30, 2028**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, in March 2023, the Human Services Agency (HSA) issued a Request for Proposals (RFP) to identify providers of child abuse prevention services under a Family Resource Center model at school-based sites and in-home to at-risk families with children aged 0-18 and Family Connections was selected based on their capacity, experience, and method of providing these services; and

WHEREAS, on October 17, 2023, by Resolution No. 080004, the County entered into an agreement with Family Connections to support families and provide child abuse prevention services for the term of October 1, 2023 to June 30, 2026, with a total obligation amount of \$989,855; and

WHEREAS, the agreement with Family Connections supports parents in building positive parenting skills while addressing their behavioral and mental health needs and helps children make individualized developmental progress; and

WHEREAS, on December 2, 2025, by Resolution No 081538, the County authorized an amendment to increase funding by \$65,000 for a new total obligation amount of \$1,054,855, to add supplemental funding received by the American Rescue Plan Act of 2021 (ARPA) to strengthen family-focused, community-based initiatives aimed at preventing child abuse and neglect; and

WHEREAS, on May 7, 2026, HSA executed a director-level amendment to increase the term by 2 years for a new term of October 1, 2023 through June 30, 2028, with no change to the total obligation amount, to continue to provide child abuse prevention services for the additional term; and

WHEREAS, HSA is requesting the County to amend its agreement with Family Connections to increase funding by \$747,100, for a new total obligation amount of \$1,801,955, for a term of October 1, 2023 to June 30, 2028, to cover the cost to continue providing child abuse prevention services for additional term authorized by the prior amendment; and

WHEREAS, this Board has been presented with a form of said amendment, has examined it and approved it as to both form and content, and desires to enter into it.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors be and is hereby authorized and directed to execute said amendment for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Director of the Human Services Agency or designee is authorized to execute contract Amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
