Master Services Agreement

- Encompasses 8 vendors essential to elections operations
- Term: 1 to 5 years with 1 amendment
- Funding: \$15,656,480
- Provides legal, fiscal, and administrative oversight while preserving operational flexibility
- Ensures secure, accurate, and timely administration of elections
- Best procurement practices followed in the selection of these vendors

Elections Code Section 14100


“[t]he county elections official, in providing the materials required by this division, shall not be required to utilize the services of the county purchasing agent.”



Legal and Statutory Authority

San Mateo County Ordinance 2.83.100 – Elections Supplies

“It shall be the duty of the County Clerk to purchase all elections supplies. Such supplies shall be purchased by the County Clerk in the manner provided by the Elections Code, and the Purchasing Agent shall have no duty or authority relating thereto.”
