AMENDMENT NO. 2 TO AGREEMENT BETWEEN THE SAN MATEO COUNTY FLOOD AND SEA LEVEL RISE RESILIENCY DISTRICT AND THE COUNTY OF SAN MATEO

THIS SECOND AMENDMENT TO THE AGREEMENT ("Amendment No. 2") is entered into effective July 1, 2025, by and between the SAN MATEO COUNTY FLOOD AND SEA LEVEL RISE RESILIENCY DISTRICT ("District") and COUNTY OF SAN MATEO ("County") (together, the "Parties").

On October 1, 2023, the Parties entered into an agreement under which the County was retained by the District to continue the management and operations of the Flood Zones and to support the District's long-term operations by providing engineering services for the management and operations of the Flood Zones and flood-related projects in the Flood Zones ("Agreement"); and

The Agreement includes a not-to-exceed amount of \$4,870,000 and expires on June 30, 2024, with an option to extend through June 30, 2025, upon mutual consent.

On, July 1, 2024, the Parties entered into Amendment No. 1 of the agreement, which exercised the option to extend the term of the Agreement to June 30, 2025; and

The Parties wish to extend the term of Agreement to June 30, 2026.

Extension of Agreement Term

The first paragraph of Section 4 of the Agreement entitled "Term" is hereby replaced in its entirety with the following:

"Subject to compliance with all terms and conditions, the term of this Agreement shall be from October 1, 2023, through June 30, 2026."

- 1. <u>All Other Terms Unaffected</u>. All other terms and conditions of the Agreement are unaffected by this Amendment and shall remain in full force and effect.
- 2. <u>Counterparts & Electronic Signatures</u>. This Amendment No. 2 may be executed in any number of counterparts, each of which will be deemed an original and all of which together will constitute a complete agreement. Moreover, this Amendment No. 2 may be signed by electronic signature and copies of original signatures shall be treated the same as the originals.

Exhibit A – County Department of Public Works Scope of Services Revised for Amendment No. 2

The following is a description of engineering services provided by the Department of Public Works for the San Mateo County Flood and Sea Level Rise Resiliency District (District) on a time and materials basis. Activities listed below are anticipated for the continued maintenance and operations of the Flood Zones' constructed or funded infrastructure while previously governed by the County of San Mateo Board of Supervisors, but may not include all activities required or requested to maintain operations.

General Work for all District-managed Flood Zones

Activities:

- Assist with preparation and monitoring of budgets related to the anticipated costs and expenditures to be incurred by County
- Assist with the Municipal Regional Permit (MRP) reporting for all District-managed Flood Zones for FY24-25
- Assist District in obtaining necessary permitting, licenses, or approvals from regulatory agencies for emergency work
- Assist with existing or proposed easements, Colma Creek Flood Control Zone (CCFCZ) owned property, and CCFCZ lease agreements for due diligence of land transfers between San Mateo County and District (OneShoreline)
- Respond to data and information requests as appropriate

Colma Creek Flood Control Zone (CCFCZ)

Activities:

- Facilitate long-term routine maintenance permitting, licenses, and approvals from regulatory agencies for the CCFCZ
- Work in compliance with and as required by the maintenance permit for Colma Creek Flood Channel (Channel), including preparing relevant agency notification in May 2025 and reporting by December 2025
- Perform 2025 routine maintenance work, including observation and inspection of work, field meetings, providing access to channel, and required maintenance dredging as needed
- Perform work to support the Culvert Repair and Replacement Project from Highway 101 to Utah Ave such that construction can commence and be completed, including observation and inspection as needed
- Facilitate ongoing conditions assessment as needed including field meetings and providing access to channel
- Provide information as requested to be included in documents presented to the Colma Creek Citizens Advisory Committee at their quarterly meetings

San Bruno Creek Flood Control Zone (SBCFCZ)

Activities:

- Facilitate maintenance, monitoring, and repairs for the SBCFCZ pump stations (Angus and Walnut Pump Stations, collectively "Pump Stations") including regulatory permit reporting
- Facilitate and coordinate vegetation management on Cupid Row Channel and proximate to Pump Stations facilities for 2025 routine maintenance and reporting, and in compliance with the Memorandum of Understanding (MOU) with San Francisco International Airport (SFIA) for West of Bayshore Property and San Francisco Garter Snake (SFGS) Recovery Action Plan

National Pollutant Discharge Elimination System (NPDES) Countywide and Pacifica Fees - Levied on the Property Tax Bill

Activities:

- Work associated with confirming accuracy of NPDES fees from Controller's Office prior to being levied on the tax roll (FY 2025-26 Property Tax Bill)
- Coordination with C/CAG and their contractor for property owner status, for properties that transfer ownership prior to 6/30/2025 (e.g. tax exempt status particularly when properties change hands)
- Coordinate as necessary on directing NPDES fee inquiries

The District acknowledges that it is responsible for all work performed at the direction of or under the terms of this Exhibit including all costs, claims and future obligations.

If the District requests engineering services not outlined in this Exhibit, the County will consider all requests based on staff availability and expertise. Additional services must be agreed upon in writing by both parties.

Rate: Department services will be billed based on the standard hourly rate in place at the time of service. District understands that rates are adjusted a minimum of annually and agrees to pay the current standard hourly rate at the time of service which may differ from the below.
