**RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH
PSYNERGY PROGRAMS, INC. FOR RESIDENTIAL MENTAL HEALTH SERVICES,
INCREASING THE AMOUNT BY \$279,000 TO AN AMOUNT NOT TO EXCEED
\$5,809,122, WITH NO CHANGE TO THE AGREEMENT TERM**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on June 25, 2024, this Board of Supervisors authorized an agreement with Psynergy Programs, Inc. to provide residential mental health services for the period of July 1, 2024 through June 30, 2027, for a maximum obligation of \$5,530,122; and

WHEREAS, under the Administrative Memorandum B-1, the selection of providers of residential services for mental health clients is exempt from the Request for Proposals requirement; and

WHEREAS, there has been presented to this Board of Supervisors for its consideration and acceptance an amendment to the agreement, reference to which is hereby made for further particulars, where Psynergy Programs, Inc. will continue to provide residential mental health services, increasing the amount by \$279,000 to \$5,809,122; and

WHEREAS, this Board has been presented with the amendment and has approved it as to both form and content and desires to enter into the amended agreement.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors be and is hereby authorized and directed to execute said agreement for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Chief of San Mateo County Health or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
