**RESOLUTION AUTHORIZING AN AGREEMENT WITH TESCO SPECIALTY
VEHICLES LLC TO PROVIDE A CUSTOMIZED MOBILE DENTAL VAN, FOR THE
TERM OF AUGUST 1, 2025 THROUGH OCTOBER 31, 2025, IN AN AMOUNT NOT
TO EXCEED \$349,873**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, San Mateo Medical Center's (SMMC) mobile dental clinic provides essential oral health services throughout San Mateo County, serving vulnerable and underserved populations, including individuals experiencing homelessness, low-income families, and residents in remote or hard-to-reach areas; and

WHEREAS, to expand the program's reach and increase access to dental services, SMMC released a Request for Proposals (RFP) for the purchase of a new, fully equipped mobile dental van; and

WHEREAS, TESCO Specialty Vehicles LLC (Tesco) was elevated due to its proven experience in designing custom mobile healthcare units, including dental vans, and its ability to meet the program's technical specifications within budget; and

WHEREAS, Tesco has agreed to provide the County with a customized, fully equipped mobile dental van in an amount not to exceed \$349,873; and

WHEREAS, this Board has been presented with a form of such agreement, has examined and approved it as both form and content, and desires to enter into it.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of the Board of Supervisors be and is hereby authorized and directed to execute said agreement for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Chief of San Mateo County Health or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate) and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.

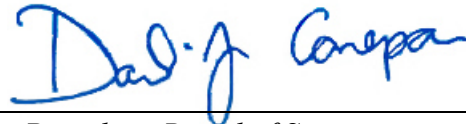
