SECOND AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND

CHILD CARE COORDINATING COUNCIL OF SAN MATEO COUNTY

THIS AMENDMENT TO THE AGREEMENT, hereinafter called "Agreement," entered into this June 25, 2024 by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Child Care Coordinating Council of San Mateo County, hereinafter called "Contractor";

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for Stage 2 child care services on June 13, 2023 for the term of July 1, 2023 through June 30, 2024 for a total obligation amount not to exceed \$239,198; and

WHEREAS, the parties amended the agreement on November 11, 2023 to decrease the total fiscal obligation by \$7,657, for a revised total obligation amount not to exceed \$231,541; and

WHEREAS, the parties wish to further amend the Agreement to increase the total fiscal obligation by \$658,459 for a revised total obligation amount not to exceed \$890,000, and extend the term by 12 months for a revised term of July 1, 2023 through June 30, 2025.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 4 – Payments of the Agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions and specifications set forth herein and in Exhibits A and C, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment is County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed **EIGHT HUNDRED NINETY THOUSAND DOLLARS** (\$890,000.00)

2. Section 5 – Term and Termination is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from July 1, 2023 through June 30, 2025.
