SECOND AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND JOHNSON CONTROLS, INC.

THIS AMENDMENT TO THE AGREEMENT, entered into this day of,
2024, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Johnson Controls
Inc., hereinafter called "Contractor";

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for security system related services on January 22, 2024 for the term of July 1, 2023 through June 30, 2024, in an amount not to exceed \$200,000; and

WHEREAS, on May 7, 2024, the parties amended the Agreement to increase the amount of the Agreement by \$75,000 to an amount not to exceed \$275,000; and

WHEREAS, the parties wish to amend the Agreement to increase the amount of the Agreement by \$30,000 to an amount not to exceed \$305,000.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

- 1. Section 3, Payments of the agreement is amended to read as follows:
 In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed THREE HUDNRED FIVE THOUSAND DOLLARS (\$305,000). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement. All invoices must be approved by the Chief Operating Officer or their designee. Invoices must be sent to: SMMC-Accounts-Payable@smcgov.org. Processing time may be delayed if invoices are not submitted electronically.
- 2. Original Exhibit B is hereby replaced with Revised Exhibit B, (rev. 7/22/24), a copy of which is attached hereto and incorporated into the Agreement by this reference.
- 3. All other terms and conditions of the agreement, as previously amended, between the County and Contractor shall remain in full force and effect.
