2024 Garbage and Recycling Rates

Recommend 13.6% increase for CFA

Commonly used residential carts will increase:

- \$5.00 for 20-gallon service (\$36.74 increases to \$41.74/month)
- \$5.94 for 32-gallon service (\$43.67 increases to \$49.61/month)

Commercial:

- \$5.94 for 32-gallon service (\$43.67 increases to \$49.61/month)
- \$30.77/month increase for 1-yard bin \$226.22 to \$256.99









Agency Roles in CSA-8 Waste Services

SBWMA Responsibilities:

- 11-member agency with Governing Board
- Contract oversight for:
 - Collection of Waste, Recycling, Organics (Recology)
 - Shoreway Environmental Center (South Bay Industries)
 - Processing and Disposal (South Bay Industries)
- Annually Allocate Required Costs to Jurisdictions


County Responsibilities:

- Set Rates Annually
- Ensure Contractor Compliance
- Make Program Recommendations
- Conduct Special Events
- Manage Customer Feedback
- One of 11-Member Agency

Development of 2024 Rates

1. New Costs Approved by SBWMA

- New Processing & Disposal Contract
- Labor and Fuel Indices
- Additional services

2. Costs Allocated to CSA-8

- o 19.3% gap
- Cost of Service approach

3. Strategies to reduce rates from 19.3% to 13.6%

- SBWMA Applied Rate Stabilization Fund
- Board Approved \$96K Use of Reserves
- Board Approved Recology Cap & Carry Forward
- Two-year transition to 19.3% in 2025



2024 Rate Recommendations

Recommend 13.6% increase for CFA

Commonly used residential carts will increase:

Ratepayer Notification

- Prop 218 requires notification 45 days in advance of hearing
- Sent mailers of proposed rates and hearing date to all parcels: December 2023
- Published 2 newspaper postings of public hearing: January 2023

Adopt a resolution to adopt the 2024 Garbage and Recyclables Collection Rates for Unincorporated Franchised Area (CFA) for services provided pursuant to the Franchise Agreement for the CFA, as set forth in Exhibit "A" to this Resolution.
