WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for on-call architectural design services on October 8, 2019; and

WHEREAS, by authority of Resolution 077031(c), the parties amended the Agreement on August 8, 2022 extending the term of the agreement to October 7, 2024; and

WHEREAS, by authority of Resolution 077031(c), the parties amended the Agreement on December 18, 2023 to increase the not to exceed amount by \$25,000 for a new not to exceed amount of \$625,000; and,

WHEREAS, the parties wish to amend the Agreement to allow the KPA Group, Inc. to continue architectural design services for the San Mateo Medical Center Elevator Project, Elections Registration Elevator Project, as well as other Capital Improvement Plan projects increasing the not to exceed amount by \$300,000 for a new not to exceed amount of \$925,000 with no change in term.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3. Payments is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal

obligation under this Agreement exceed **Nine Hundred Twenty-Five Thousand Dollars** (\$925,000.00). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.

4. All other terms and conditions of the agreement dated October 8, 2019, between the County and Contractor shall remain in full force and effect.
