RESOLUTION AUTHORIZING THE CHIEF PROBATION OFFICER, OR DESIGNEE, TO EXECUTE AN AGREEMENT WITH THE CALIFORNIA DEPARTMENT OF CORRECTIONS AND REHABILITATION (CDCR) TO PLACE ELIGIBLE NON-MINOR WARDS, ONLY PURSUANT TO JUVENILE COURT ORDER, TO HOUSE, SUPERVISE, AND TRAIN COURT-APPROVED NON-MINOR YOUTHFUL OFFENDERS AT THE PINE GROVE YOUTH CONSERVATION CAMP, EFFECTIVE UPON EXECUTION THROUGH JUNE 30, 2028, IN AN AMOUNT NOT TO EXCEED \$43,086

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that:

WHEREAS, Senate Bill (SB) 823, enacted in 2020, initiated the closure of the California Division of Juvenile Justice (DJJ) and shifted responsibility for the care and custody of DJJ-eligible youth to county probation departments; and

WHEREAS, under SB 823, counties are authorized to establish Secure Youth Treatment Facilities (SYTFs) and use Juvenile Justice Realignment Block Grant (JJRBG) funds to support local rehabilitation, treatment, and reentry programs for realigned youth; and

WHEREAS, San Mateo County's Juvenile Justice Realignment Block Grant Plan for 2025 identifies Pine Grove Youth Conservation Camp—operated by CDCR and CAL FIRE—as a potential program to support vocational training and reentry efforts for eligible SYTF youth; and

WHEREAS, Pine Grove provides hands-on training in firefighting and conservation work in a structured, service-oriented environment, and is available to

court-approved non-minor male youthful offenders ages 18 to 25 who are wards of the juvenile court and meet physical and behavioral criteria; and

WHEREAS, before youth can be referred to Pine Grove, the County must enter into a contract with CDCR to reserve beds and coordinate placements; and

WHEREAS, the proposed agreement with CDCR would reserve up to three beds for San Mateo County youth at Pine Grove, on a pay-as-you-go basis, to be funded by the County's allocation of JJRBG funds with no net County cost;

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors of the County of San Mateo hereby authorizes the Chief Probation Officer, or designee, to execute an agreement with CDCR to house, supervise, and train court-approved youthful offenders at Pine Grove Youth Conservation Camp, effective upon execution through June 30, 2028, in an amount not to exceed \$43,086.

BE IT FURTHER RESOLVED that the Chief Probation Officer or his designee is authorized to execute contract amendments that modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
