

**THIRD AMENDMENT TO AGREEMENT
BETWEEN THE COUNTY OF SAN MATEO AND
SAN MATEO COUNTY COMMUNITY COLLEGE DISTRICT**

THIS THIRD AMENDMENT TO THE AGREEMENT, entered into this date _____, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and San Mateo County Community College District ("SMCCCD"), hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, on June 25, 2024, the parties entered into an agreement (the "Agreement") for a term of July 1, 2024 to December 31, 2025, for a total obligation amount not to exceed \$451,000 for the purpose of providing education, mentoring, and tutoring to CalWORKs Welfare-to-Work participants referred by the San Mateo County Human Services Agency; and

WHEREAS, on October 3, 2024, the parties amended the Agreement ("First Amendment") to make changes to the availability of classes in Fall 2025 with no change to the term or total obligation; and

WHEREAS, on November 11, 2024, the parties again amended the Agreement ("Second Amendment") to move classes from one semester to another and update the rate table respectively with no change to the term and no change to the obligation amount; and

WHEREAS, the parties wish to further amend the Agreement ("Third Amendment") to extend the term by 24 months for a new term of July 1, 2024 to December 31, 2027 and increase funding by \$616,910 for a new total obligation amount of \$1,067,910, to cover the cost to continue providing services for the additional term.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

- 1.** Paragraph 3. Payments is hereby amended to read as follows:

In consideration of the services provided by the Contractor in accordance with all terms, conditions and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit

B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed **ONE MILLION SIXTY-SEVEN THOUSAND NINE HUNDRED TEN DOLLARS** (\$1,067,910). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.

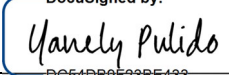
2. Paragraph 4. Term, is hereby amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from July 1, 2024 through December 31, 2027.

3. Exhibit B is hereby amended to include Course Costs, Student Costs, Tutoring Costs, and ancillary costs for the 24 months term extension and is attached hereto.
4. All other terms and conditions of the Agreement dated June 11, 2024, and the subsequent First and Second amendments, between the County and Contractor shall remain in full force and effect.
