<u>Professional Edition</u>: Client is permitted to access and use the features and functionality of the Professional Edition of the Anaplan Service as identified in the Appendix attached to this Order Schedule and as further detailed in the Documentation.

Renewal of Subscription Fees: The parties may renew this Order Schedule in writing for an additional five- year term subject to Anaplan's right to increase such fees up to three percent (%) ("Uplift Rate") in each year of the renewal. Should the parties fail to renew in writing before the end date of this Order Schedule, the Uplift Rate is no longer applicable and the parties shall renew at Anaplan's then current rates or as otherwise agreed by the parties in writing.

### **Marketing & Publicity:**

Name & Logo: Anaplan may use Client's name and logo on Anaplan's website and marketing collateral subject to compliance with branding guidelines provided by Client.

Anaplan Data Orchestrator (ADO) package: ADO is an additional online service providing data integration and staging capabilities. Each package includes an additional 25 GB of managed data. ADO optimizes data for distribution throughout the Client's Anaplan tenant environment, with the ability to connect to external data sources both on cloud and on-premise. It enables the Client to transform, validate, and enrich that data, and publish it into Anaplan modeling environments. Managed Data refers to data that is retained from sessions to session; either persisted from prior sessions or refreshed by the available connectors. A session is when ADO is actively running in a customer tenant. A refresh is a feature where connectors update the data that is in the ADO from the source application and replaces the current data with the latest data. Please reference ADO Documentation for the latest supported connectors, fair use policy, and further details. The offering does not entitle or change the customer's contracted users, workspace capacity, or features. Client is entitled to one (1) package for the full five-year term.

**Anaplan XL Reporting**: Anaplan XL Reporting is a reporting and analytics tool which connects Excel directly and securely to the Anaplan platform. Users leverage their existing Excel skills to become productive quickly, while XL adds a comprehensive set of extended functionalities to help users work more effectively within data-connected Excel. The subscription includes coverage for the licensed number of users. Please reference the XL Documentation for further information about the latest supported features. Client is entitled to 15 users for the full five-year term.

**PlanIQ For Finance**: PlanIQ is an integrated solution that allows Authorized Users with model builder rights to build sophisticated, Machine Learning (ML)-driven planning scenarios and forecasting models within Anaplan for the finance use case. Client is entitled to one (1) package starting in year 2 of this Order Schedule.

**Read-Only User**: An Authorized User with read-only access to model dashboards. Client is entitled to 5,000 users for the full five-year term.

**Workflow User**: Enables access to the Workflow functionality within Anaplan. ### APPENDIX TO ORDER SCHEDULE

#### PROFESSIONAL EDITION

The Professional Edition of the Anaplan Service includes the following features and functionality:

- Hyperbyte Allowance Right to use an aggregate amount of Hyperbytes calculated as four Hyperbytes (4GB) for each
  Connected Planning Professional User and Connected Planning Model Builder. A Hyperbyte is a unit of in-memory data
  processing capacity within the Anaplan Service, measured in 1 gigabyte (GB) increments.
- Anaplan Applications Right to deploy Anaplan Applications from the App Hub.
- Core Model Building Functionality Model business processes by defining the data model, dimensions and hierarchies, calculations, workflow, with administrative capabilities including user management, model management and visual model maps. Requires Connected Planning - Model Builder rights.
- Dashboard Design Design and share interactive dashboards that include data reports, standard visualizations (column, bar, line, pie, waterfall and timeline charts) and pre-defined user actions. Requires Connected Planning - Model Builder rights.
- Dashboard Interactivity View and interact with dashboards (including charts) to view, filter, sort or pivot data, enter data and perform actions as enabled within a dashboard.
- Statistical Calculations Statistical calculation functions for modeling, segmentation analysis, forecasting and call center functions.
- Microsoft Office Integration Transfer data between Anaplan and Microsoft Excel and PowerPoint, with updates in real time for presentation in those Microsoft applications.
- Self-Service Data Import & Export Authorized Users may import and export data through the web-based interface.
- Bi-Directional APIs Programmatic integration with the Anaplan Service through Anaplan APIs.
- ETL Connectors Standardized Connectors facilitating integrations between the Anaplan Service and third-party services for bi-direction data transfer using ETL (Extract, Translate, Load) tools.
- Change History Automatic tracking of model changes.
- Single Sign-On Right to enable single sign-on access to the Anaplan Service using the SAML 2.0 protocol.
- On-Demand Virtual Online Training Right to access the on-demand virtual training made available to Authorized Users of the Anaplan Service.
- Application Lifecycle Management (ALM) Manage, update and synchronize models and applications across production, development and test environments.
- Anaplan Audit -Anaplan Audit provides customers access to the last 30 days of audit logs for their tenant. Please see the Documentation for Anaplan Audit for further information.

## **APPENDIX TO ORDER SCHEDULE:**

### **PLANIQ FOR FINANCE**

PlanIQ allows clients to build sophisticated, ML driven planning scenarios and forecasting models within the Anaplan Service. With PlanIQ users can create and optimize plans based on business needs and forecasts within the finance function.

PlanIQ could be used for the following example application:

 Financial planning - quickly generate OpEx forecasts and analyze new scenarios, variances, and opportunities so board members can speed up decisions.

Client is entitled to up to 240,000 Predictions per month, which may be used in varying amounts and forecasting frequency as Client desires. For example:

- 60,000 Predictions with 4 reports per month, or
- 30,000 Predictions with 8 reports per month, or
- Any other combinations of Predictions and report frequency, provided Client does not exceed 240,000 Predictions per month.

Predictions are allocated on a monthly basis, and Predictions that are not utilized within the month allocated may not be carried forward.

A Prediction is a single item that is being forecasted ("Prediction"). For a finance use case, a Prediction might be a budget forecast line item, for example spend category or cost center. Predictions are consumed each time a forecast is generated. Every item that is part of the forecast output is considered a prediction point for this purpose.

PlanIQ offers Client the ability to use multiple prediction algorithms, some of which are provided by third party service providers, in which case additional terms of those third-party service providers shall apply (such as acceptable use policies, etc.). Please see <a href="https://www.anaplan.com/legal/PlanIQ">www.anaplan.com/legal/PlanIQ</a> for additional terms for those third-party service providers. Anaplan will delete all Client Data from PlanIQ within thirty (30) days of Client's termination of the PlanIQ subscription, however anonymized machine learning algorithms, which do not contain any Client Data, will remain as part of Anaplan's trained algorithms. The machine learning algorithms shall only be used internally by Anaplan for the purpose of further model training.

Exhibit: HyperModel

HyperModel: The workspace that supports HyperModeling. Changes in workspace sizes may be requested in any increments from 131GB to 720GB. The HyperModel workspace resides on a separate server from our standard workspaces and requires a minimum of 2 weeks to deliver. Included in this SLA are:

- 1. The creation of a new HyperModel workspace
- 2. Changes to the size of an existing HyperModel workspace

In the event of a migration and consolidation of multiple standard workspaces into one or more HyperModel workspaces, Client may temporarily borrow capacity during the permitted transition period.
