DEPARTMENT UPDATE

San Mateo County Parks Commission October 3, 2024

<u>Visitor Experience</u>

Visitor Data

The San Mateo County Parks Department will report visitor data to the Parks Commission on a quarterly basis; however, because visitor data is submitted to the office on the first day of the following month (submitted on October 1 for September) and the Commission meets on the first Thursday of each month, the data will be reported two months after the end of the quarter. For example, Quarter 3 data will be reported in the November Department Report.

Interpretive Events

Between July and September of 2024, the Interpretive Division hosted or participated in 58 events, including the Memorial Park 100-year anniversary celebration, Summerfest at Coyote Point Recreation Area, classroom programs on wildlife and habitats, a Big Lift event, Junior Ranger activities, library and book mobile events, and Take a Hike events. In total, approximately 3,791 people were served by the division. The details of each event are included in this report as Attachment 1.

Volunteer Events

The Volunteer Program hosted 98 volunteer events throughout the parks system between January and July 2024. Events included various planting, weeding, and mulching events for invasive plant control and habitat restoration, and trail restoration and rehabilitation projects. These events totaled 7,031 hours of volunteer effort supporting and improving the parks. The details of each event are included in this report as Attachment 2.

Facilities and infrastructure

Don Horsley County Park at Tunitas Creek Beach

At the September 24, 2024 Board of Supervisors meeting, Supervisor Slocum and Supervisor Mueller introduced a resolution to name the Tunitas Creek Beach property "Don Horsley County Park at Tunitas Creek Beach", to honor the memory of former sheriff and supervisor Don Horsley and all of his contributions to the residents of San Mateo County including the creation of the newest County park. This resolution passed unanimously. For more information on County facility naming by the Board of Supervisors, see County Ordinance 2.52 in Attachment 3.

Amenities at Don Horsley County Park are continuing to take form. The parking lot, ADA pathway to the midbluff, and overlooks have been graded; the restrooms and ranger station are almost completed; and the benches at the amphitheater have been installed. All hardscape is scheduled to be constructed by the end of October/early November, with handrails, guardrails, and landscaping to follow. Substantial completion is scheduled for December 20, 2024. Depending on weather, Don Horsley County Park

at Tunitas Creek Beach could be open to the public as soon as December 2024.

Realize Flood Park

Construction of Phase 1 of the Realize Flood Park Project continues to progress. The small multi-use sports field, tennis/pickleball court, basketball court, sand volleyball court, expanded parking lot, and walking paths in the eastern segment of the park are scheduled to be completed in early November 2024 and opened to the public before Thanksgiving. Picnic and reservation sites, walking paths in the western segment of the park, and the meadows will open to the public in early 2025.

Design efforts for the new playground at Flood Park playground continue, using the preferred project alternative known as Boulder Canyon as the direction for equipment selections and layout. The Department is working with its consultants, CMG Landscape Architecture, to select the appropriate equipment and prepare detailed engineered plans for construction. The playground, which will be inclusive in design, will include a double tower with a bridge, spin zone, swing bank, double zipline, tot lot, interactive boulders and logs, and seating.

Coyote Point Recreation Area

Throughout 2024, the Department has been engaging with the public to better understand what experiences people would like to have at Coyote Point. In early September, a survey closed regarding two alternative concept plans with ecology forward alternative and an activity forward alternative in various zones of the park. The ecology forward alternative focuses on landscape restoration and passive amenities that allow for people to connect with nature, like trails and picnic sites. The activity forward alternative focuses on building new recreational amenities, creating new opportunities to play, and enabling more community events. Results of this summer's online survey are being tabulated and will be released to the public this fall. The Department intends to present the findings and resulting concepts to the Commission by the end of 2024.

San Bruno Mountain Day Use Improvement Project

Construction of the construction of the new day use area restroom and open-air interpretive pavilion facility is scheduled to start in spring 2025. Upgrades to the picnic sites and access paths will now also start concurrently with the restroom and interpretive pavilion building work next spring, to increase cost and schedule efficiencies for the project.

Natural Resource Management

Wildfire Hazard Reduction at Junipero Serra County Park

The department received a grant award from the Federal Emergency Management Agency (FEMA) under their Hazard Mitigation Grant Program to complete fuel reduction efforts at Junipero Serra County Park. The grant award is for \$284,287 in federal funds for the project and will entail understory thinning and hazardous tree removals within 100 to 200 feet of park boundary areas, to establish a shaded fuel break. The total project size is approximately 22 acres.

San Mateo County, CA Code of Ordinances

Chapter 2.52 FACILITY NAMING

2.52.010 - Purpose.

Many individuals have made significant contributions to the citizens of the County of San Mateo through their work, their civic involvement, or through their monetary or other donations to the County and to foundations which provide support to County programs. It has been the County's policy to recognize and honor such contributions when appropriate to do so. One method of recognizing significant contributions to the County is through the naming of County facilities in honor of the individual for his or her contribution.

It is the intent of the Board that the naming of a County facility only occurs in exceptional circumstances, taking into account the time period over which any contribution is made, the number of people affected by the contribution, and the extent to which the County's population has been affected to the better by the actions of the individual proposed for recognition.

2.52.020 - Applicability.

For purposes of this chapter, "facilities" shall include substantial structures, open spaces, or natural features, including, but not limited to, buildings, wings of buildings, indoor or outdoor auditoriums, gardens, parks, tree groves, plazas and trails, but shall not include small meeting rooms, park benches, or similar small structures. (Ord. 4413, 02/26/08)

2.52.030 - Nominations.

Nominations for recognition by the naming of a facility may be made by any member of the Board of Supervisors by bringing the nomination directly to the Board, or by referring the nomination to the County Manager. All other nominations shall be made to the County Manager on an application form created by the County Manager. The County Manager shall conduct such review as the County Manager deems necessary, including, but not limited to, the referral of the application to a review panel; and shall make a recommendation to the Board after any required waiting period. Any such recommendation shall be to approve the application to name the requested facility, to deny the application, or to honor the individual in some other way. (Ord. 4413, 02/26/08)

2.52.040 - Criteria.

In order to be considered for recognition by the naming of a facility, the individual must have made a significant contribution to public service or the betterment of San Mateo County, through service as an employee of a governmental organization or non-

governmental organization, through service as a volunteer, or through a significant monetary contribution or dedication of property to the County, or through similar contributions to foundations which directly support County activities and facilities. Particular consideration should be given to the following:

The period of time over which the individual made a significant contribution; The number of people that were directly or indirectly impacted by the contribution; The extent to which the actions of the individual bettered the lives of those impacted by the contribution.

Recognition by naming shall be limited to the naming of a single facility, except in extraordinary circumstances, in which case such recognition may be extended to a collection of facilities.

RECOMMENDATION:

Make a recommendation to the San Mateo County Board of Supervisors to appropriate and spend \$58,656.16 from the Fish and Game Propagation Fund's FY 2024-25 Recommended Budget to the following applicants: San Bruno Mountain Watch (\$11,500); San Mateo County Parks Foundation (\$15,000); San Mateo Resource Conservation District (\$22,156.16); and Vida Verde Nature Education (\$10,000).

BACKGROUND:

The Fish and Game Propagation Fund ("Fund") is a special revenue fund maintained by the San Mateo County Parks Department ("Department") and comprised of revenue generated when individuals are fined for violating Sections 12009 and 13003 of the California Fish and Game Code while in San Mateo County. Pursuant to Section 12009, "the money collected from any fine or forfeiture imposed or collected for the taking of abalone for any purpose other than for profit in violation of this article or any other provision of law shall be deposited" in the treasury of the county in which the violation occurs. Section 13003 states that "[u]nless otherwise provided by law, all fines and forfeitures imposed or collected in any court of this state for violations of any of the provisions of this code or regulation made pursuant thereto, or any other law providing for the protection or preservation of birds, mammals, fish, reptiles, or amphibia, shall be deposited as soon as practicable after the receipt thereof with the county treasurer of the county in which the court is situated."

Section 13100 of the California Fish and Game Code provides that "[t]he amounts paid to and retained in the county treasury pursuant to Sections 12009 and 13003 shall be deposited in a county fish and wildlife propagation fund and expended for the protection, conservation, propagation, and preservation of fish and wildlife, under the direction of the board of supervisors, pursuant to this chapter." Pursuant to County Ordinance Code Section 2.63.020, the Parks and Recreation Commission ("Commission") shall make recommendations to the County's Board of Supervisors regarding the expenditure of fish and game propagation funds.

At its April 4, 2024 meeting, the Commission adopted Fish and Game Propagation Fund Guidelines to set forth the process by which the Commission: (1) solicits, receives, and evaluate applications from individuals residing in San Mateo County, and/or 501(c)3 organizations, fiscally sponsored community projects, accredited academic institutions, and government agencies, including special districts, seeking fish and game propagation funding; and (2) makes recommendations to the Board regarding the expenditure of Fish and Game Propagation funds. These guidelines included establishing a set schedule and application process through which applicants can request funding for eligible projects. At its June 6, 2024 meeting, the Commission established an Evaluation Committee comprised of one Commissioner and two Department staff (the Parks Director and Parks Assistant Director).

On July 23, 2024 the Department opened the grant application process and published all application materials and guidelines publicly to the Department's website. The due date for applications was August 22, 2024.

The FY 2023-24 Year-End Fund Balance for the Fish and Game Fund was \$61,096.

DISCUSSION:

The Department received five timely applications for Fish and Game Propagation funds. A summary of each application, as well as the Evaluation Committee's recommendation to the Commission for its consideration, are detailed below.

1. <u>San Bruno Mountain Watch: San Bruno Mountain Rare, Threatened and Endangered Plant Propagation Project</u>

The San Bruno Mountain Watch's Rare, Threatened and Endangered Plant Propagation project is a collaborative effort to increase the abundance and expand the geographic distribution of rare, threatened, and endangered plant species on San Bruno Mountain. In 2015, a survey regarding rare, threatened, and endangered (RTE) plant species on San Bruno Mountain was conducted and provided recommendations for management. The project for this funding request proposes to implement the recommended management and stewardship efforts for four of the plants most urgently prioritized in the 2015 survey—the San Francisco campion (*Silene verecunda ssp. verecunda*), Pacific manzanita (*Arctostaphylos pacifica*), Leo Brewer's Manzanita (*Arctostaphylos uva-ursi forma leobreweri*) and miniature manzanita (*Arctostaphylos uva-ursi forma suborbiculata*).

This project is eligible for funding under the California Fish and Game Code section 13103(e) as the proposed project focuses on restoration and recovery of some of the most vulnerable plant species at San Bruno Mountain, which is also critical habitat for 4 species of federally protected butterflies – mission blue, callippe silverspot, San Bruno elfin, and bay checkerspot butterflies.

The project requests \$11,500 from the Fish and Game Fund, with \$38,262 in

matching funds and a total project cost of \$49,762.

The Evaluation Committee supports a recommendation to the Board of Supervisors to award Fish & Game Propagation Funds to this applicant in the amount requested (\$11,500).

2. <u>San Mateo County Parks Foundation: Memorial County Park Nature Center</u> Interpretive Media

The San Mateo County Parks Foundation proposes to implement the Memorial County Park Nature Center Improvement Project with support from the Fish and Game Propagation Fund. Through this project, new interpretive media will be installed at the Memorial County Park Nature Center that supports public education related to fish and wildlife conservation, in alignment with California Fish and Game Code 13103(a).

The new interpretive media will educate the public on these fish and wildlife conservation topics:

- Ecological concepts of watersheds, creeks, riparian areas, and redwood forests
- Flora and fauna that can be found in the park
- Forest health, fire ecology, and ways to reduce risk of wildfire
- Significance of Pescadero Creek as breeding grounds for steelhead trout and implications for visitor use
- Presence of the endangered Marbled Murrelet and the need for campers to support its conservation by keeping campsites "crumb clean" which reduces the presence of predatory crows and jays
- Visitors' role in the protection and active stewardship of parklands and forests to benefit fish and wildlife

This project is eligible for funding under the California Fish and Game Code section 13103(g) as the project will allow the Department to create and own educational and interpretive material pertaining to the scientific principles of fish and wildlife conservation for use at Memorial County Park.

The applicant requests \$15,000 from the Fish and Game Fund, with \$66,040 in matching funds and a total project cost of \$81,040.

The Evaluation Committee supports a recommendation to the Board of Supervisors to award Fish & Game Propagation Funds to this applicant in the amount requested (\$15,000).

3. <u>San Mateo Resource Conservation District: Memorial County Park PIT Tag</u>
<u>Antenna Array Project</u>

The San Mateo RCD's Coastside Salmonid Monitoring Project addresses a critical

need for long-term monitoring of threatened and endangered salmonid populations in the Pescadero-Butano watershed. This project utilizes passive integrated transponders (PIT) tags and paired antennas (array) to detect the movements of coho and steelhead within the watershed. The Memorial County Park array site is the project that this application seeks reimbursement for under this grant. Data collected will be shared with the Department's Natural Resource Management Division to inform management and restoration of the creek.

This project is eligible for funding under the California Fish and Game Code section 13103(i) as the project focuses on data collection for monitoring population trends and movement of fish species by qualified researchers and organizations.

The applicant requests \$22,156.16 from the Fish and Game Fund, with \$22,156.16 in matching funds and a total project cost of \$44,312.31.

The Evaluation Committee supports a recommendation to the Board of Supervisors to award Fish & Game Propagation Funds to this applicant in the amount requested (\$22,156.16).

4. <u>Steve Kennedy: The Cannonball Express" (Elementary School Version)</u>

This application requests Fish and Game Funds to create a video for use in school curriculum that will "that will encourage kids in grades 5 & 6 to get into the training and education pipeline for the jobs of tomorrow that will help us prepare for, prevent and mitigate the kind of devastating and deadly suburban forest fire that San Mateo County has not yet experienced". The described project would be to "create a video from a simple coming-of-age story line about two kids and their adult neighbors [that is] much more than an aid to education. The members of the Video Project Committee will bring stakeholders together to influence (County Parks) land management, energy and educational policy makers on the trillion dollar issue of suburban forest fires".

The applicant requests \$5,000 from the Fish and Game Fund and a total project cost of \$10,000; however, the applicant indicates that the required matching funds are not secured, and they would need to seek funding from other sources.

The Evaluation Committee has determined that Mr. Kennedy's application is incomplete, as the applicant did not provide all items/information required by the Commission's Fish and Game Propagation Fund Guidelines. Specifically, the applicant did not provide the signed grant application form or the signed proposed project budget. Additionally, the applicant has not secured the required 50% matching funding is for the project.

Because this application did not meet minimum qualifications to be properly evaluated, and all required items for the application were not provided by the applicant, the Evaluation Committee does not support a recommendation of awarding

Fish & Game Propagation Funds to this applicant.

5. <u>Vida Verde Nature Education: Multi-day Environmental Education Experiences</u> for Students from Low Income Bay Area Schools

Vida Verde Nature Education is a nonprofit corporation based in San Gregorio that promotes educational equity by providing free overnight learning experiences for 4th-6th grade students through overnight camping programs during the school year. Each camping trip includes a three-day overnight, activity packed experience at a 100-acre farm, as well as field trips to nearby parks and beaches. The program centers around five core components: (1) nature hike in the redwoods at Sam McDonald County Park, (2) goat milking and cheese making, (3) tidepool, beach, and marsh exploration in Pescadero, (4) night-time hike and trust walk, and (5) organic farm tour and tasting.

Students engage with natural science through the camping trip with activities linked to California state education standards, including topics such as the history, ecology, and special habitats of redwood forests, decomposers and their importance in the forest ecosystem, flora and fauna adaptations, tidepool exploration, and first-hand exploration and appreciation for various environments.

This project is eligible for funding under the California Fish and Game Code section 13103(a) as the proposed project focuses on education relating to the scientific principles of fish and wildlife conservation.

The applicant requests \$10,000 from the Fish and Game Fund, with \$10,581 in matching funds and a total project cost of \$20,581.

The Evaluation Committee supports a recommendation to the Board of Supervisors to award Fish & Game Propagation Funds to this applicant in the amount requested (\$10.000).

FISCAL IMPACT:

Adequate funding exists within the County's Fish and Game Propagation Fund for this purpose, with no impact to the Parks Department's operating budget beyond administrative costs.
