RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH AGREEYA SOLUTIONS, INC. FOR THE SERVICES OF JAYSHREE WASNIK TO PROVIDE DATA ANALYSIS, DATA CLEANSING AND CONVERSION SERVICES FOR THE ASSESSOR PROPERTY ASSESSMENT SYSTEM (APAS) EXTENDING THE TERM FROM JUNE 3, 2021 THROUGH JUNE 30, 2024, TO JUNE 3, 2021 THROUGH MARCH 31, 2025, AND INCREASING THE AMOUNT PAYABLE BY \$132,590 FOR A NEW NOT TO EXCEED AMOUNT OF \$611,326

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on June 3, 2021, the County entered into an Agreement with AgreeYa Solutions Inc. to provide a Data Analysis services through May 31, 2022 in the amount of \$163,350; and

WHEREAS, on May 18, 2022, the parties amended the Agreement to extend the term from June 3, 2021 through May 31, 2022 to June 3, 2021 through September 30, 2022, and increase the amount payable by \$31,463 for an amount not to exceed \$194,813; and

WHEREAS, on September 13, 2022, the parties amended the Agreement to extend the term from June 3, 2021 through September 30, 2022 to June 3, 2021 through June 30, 2023, and increase the amount payable by \$139,033 for an amount not to exceed \$333,846; and

WHEREAS, on June 13, 2023, the parties amended the Agreement to extend the term from June 3, 2021 through June 30, 2023 to June 3, 2021 through November 30, 2023, and increase the amount payable by \$58,679 for an amount not to exceed \$392,525; and

WHEREAS, on November 14, 2023, the parties amended the Agreement to extend the term from June 3, 2021 through November 30, 2023 to June 3, 2021 through February 29, 2024, and increase the amount payable by \$36,353 for an amount not to exceed \$428,878; and

WHEREAS, on February 13, 2024, the parties amended the Agreement to extend the term from June 3, 2021 through February 29, 2024 to June 3, 2021 through June 30, 2024, and increase the amount payable by \$49,858 for an amount not to exceed \$478,736; and

WHEREAS, the County and AgreeYa Solutions Inc. now wish to further amend the Agreement to extend the term from June 3, 2021 through June 30, 2024 to June 3, 2021 through March 31, 2025, and increase the amount payable by \$132,590 for an amount not to exceed \$611,326; and

**WHEREAS,** this Board has been presented with a form of such Amendment, has examined and approved it as both form and content, and desires to enter into it.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED:

- 1. The President of the Board of Supervisors be and is hereby authorized and directed to execute Amendment No. 6 to Agreement with AgreeYa Solutions, Inc., for data analysis services for the Assessor Property Assessment System (APAS) on behalf of the County of San Mateo, and the Clerk of the Board shall attest to the President's signature thereto.
- 2. Authority is given to the Assessor-County Clerk-Recorder & Chief Elections Officer or designee to execute contract amendments to modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services as long as the modified term of services is/are within the current or revised fiscal provision.
