RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH TRUBRIDGE, LLC TO PROVIDE A CLAIMS EDITING SOFTWARE AND MANAGEMENT SYSTEM, EXTENDING THE TERM BY ONE YEAR THROUGH APRIL 30, 2026, AND INCREASING THE AMOUNT BY \$225,000, TO AN AMOUNT NOT TO EXCEED \$1,827,400

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the San Mateo Medical Center (SMMC) continues to have a need

for a claim editing software and management system to fulfill their operational needs in collecting outdated accounts receivables; and

WHEREAS, in June 2017, a Request for Proposals was conducted for a

software system that would provide claims editing and management; and

WHEREAS, TruBridge, LLC (TruBridge) was selected for its significant billing expertise, user-friendly software and the ability to interface with the necessary systems within County infrastructure; and

WHEREAS, an agreement was awarded for the term of May 1, 2020, through April 30, 2023, in an amount not to exceed \$1,000,000, and a subsequent amendment was approved extending services through April 30, 2025, and increase the amount of the agreement by \$602,400 to an amount not to exceed \$1,602,000; and

WHEREAS, both parties wish to extend the term by one year through April 30, 2026, and increase the amount by \$225,000, to an amount not to exceed \$1,827,400,

allowing SMMC to complete the legacy claims while undergoing the transition to a new electronic health record system; and

WHEREAS, this Board has been presented with the amendment to the agreement, has examined and approved it as both form and content, and desires to enter into it.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

President of the Board of Supervisors be and is hereby authorized and directed to execute said amendment for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Chief of San Mateo County Health or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate) and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
