#### **Quick Facts**

"Streamlining" the Job Order Contracting (JOC) process was adopted by the Board of Supervisors in 2013 by Resolution No. 072896

Public Contract Code authorizes the Board of Supervisors to award individual annual JOCs for <u>repair, remodeling, or other repetitive work</u> to be done according to predetermined unit prices

Current California Consumer Price Index maximum amount of \$5,797,275 for annual JOCs

The various individual job orders will be funded through previously approved and appropriated projects within the FY 2023-25 Adopted Budgets

There is no additional impact to the General Fund



#### **Advertisement Process**

- The Department posted the bid opportunity on the Department's website
- Bid opportunity was shared with the Builders' Exchange which provide services at the local level, specifically sharing construction bidding information via physical and/or electronic plan room
- The Department advertised in the Daily Journal for two consecutive weeks
- Gordian Group (DPW's JOC Provider) posted advertisement for upcoming opportunities on their website
- Gordian Group sent an email to approximately 300 contractors in their database within 55 miles of San Mateo County
- Gordian Group hosted an informational meeting for interested contractors to learn more about the JOC program and our Request for Proposal opportunity
