

**AMENDMENT NO. 3 TO MEMORANDUM OF UNDERSTANDING
BETWEEN THE SAN MATEO MEDICAL CENTER AND
SAN MATEO COUNTY HEALTH FOUNDATION**

THIS AMENDMENT TO THE AGREEMENT, entered into this _____ day of _____, 2026, by and between the San Mateo Medical Center (SMMC) and San Mateo County Health Foundation (SMCHF), each a “Party” and, collectively, the “Parties”;

W I T N E S S E T H:

WHEREAS, the parties entered into an Agreement, by Resolution 071934, to direct contribution and fundraising efforts to support SMMC-related initiatives on May 8, 2012;

WHEREAS, the parties amended the Agreement on August 12, 2018, and on October 29, 2020, to update provisions regarding the responsibilities of the parties, the amount and source of payments, and certain other terms of the Agreement; and

WHEREAS, the parties wish to further amend the Agreement to update the terms of SMMC’s annual contribution to SMCHF for fiscal year 2026-2027 and the following years, subject to the terms and conditions of this Amendment.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section IV, Amount and Source of Payment, of the Agreement is hereby replaced as follows:

The County of San Mateo, through SMMC, shall make an annual contribution of TWO-HUNDRED FIFTY THOUSAND DOLLARS (\$250,000) to the SMCHF to support the SMCHF’s operating expenses in the amount included in the approved SMMC budget for that fiscal year. The amount contributed each year to the SMCHF is subject to and contingent upon the annual approval of the SMMC budget by the San Mateo County Board of Supervisors, and nothing in this MOU obligates the County of San Mateo or SMMC to provide any contribution to SMCHF if funds are not allocated or available in any given year. The total amount of funding for the SMCHF under this MOU shall not exceed TWO-HUNDRED FIFTY THOUSAND DOLLARS (\$250,000) per year.

Notwithstanding the foregoing paragraph, the County of San Mateo, through SMMC, shall make a contribution to the SMCHF of THREE-HUNDRED FIFTY THOUSAND DOLLARS (\$350,000) for the 2026-2027 SMMC fiscal year (the “2026-2027 Contribution”) to support the SMCHF’s operating expenses. The 2026-2027 Contribution

is subject to and contingent upon the approval of the SMMC budget for the 2026-2027 SMMC fiscal year by the San Mateo County Board of Supervisors, and nothing in this MOU obligates the County of San Mateo or SMMC to provide the 2026-2027 Contribution if funds are not allocated or available in the 2026-2027 fiscal year. The total amount of funding for the SMCHF for the 2026-2027 SMMC fiscal year shall not exceed THREE-HUNDRED FIFTY THOUSAND DOLLARS (\$350,000).

SMCHF commits to distributing an annual minimum of 115% of SMMC's annual contribution for that fiscal year to SMMC programs, projects, or equipment and may distribute more for programs, projects, or equipment as it decides is appropriate.

- 2. All other terms and conditions of the agreement dated October 29, 2020, between the San Mateo Medical Center and San Mateo County Health Foundation shall remain in full force and effect.**
