First Amendment to Agreement Between the County of San Mateo and Peninsula Pathologists Medical Group, Inc. for Pathology Services

THIS AMENDMENT TO THE AGREEMENT, entered into this <u>20</u> day

of <u>May</u> 2025, by and between the COUNTY OF SAN MATEO, hereinafter

called "County," and Peninsula Pathologists Medical Group, Inc., hereinafter called

"Contractor";

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an agreement for pathology services for the term of June 1, 2022 through May 31, 2025, in an amount not to exceed \$ 2,600,000.00 (the "Agreement"); and

WHEREAS, the parties desire to extend the term of the agreement in order to complete a fair market value study and conclude negotiations by three months; and

WHEREAS, the amount payable under the Agreement must be increased by \$ 225,000.00 to accommodate the extra three months of services provided under the extended term;

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. <u>EXHIBIT B</u> (entitled **PAYMENTS**) subsection 1.5.1 (entitled Maximum Amount) is amended to read as follows:

In full consideration of Contractor's performance of the services described in Exhibit A, the amount that County shall pay for services rendered under this Agreement shall not exceed TWO MILLION EIGHT HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$ 2,825,000.00).

2. Section 3.1 of the Agreement (entitled "<u>Term</u>") is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from June 1, 2022 through August 31, 2026. Each consecutive 12-month period within the term of this Agreement beginning with the first day of this term

shall constitute a "Contract Year", and any period of less than a Contract Year at the end of the term shall be treated pro rata for purposes of Contract Year services and compensation. A "Contract Year" is 52 weeks.

3. All other terms and conditions of the Agreement shall remain in full force and effect.
