**RESOLUTION RATIFYING AND AUTHORIZING AN AGREEMENT WITH WOLTERS
KLUWER HEALTH, INC. TO PROVIDE A POINT-OF-CARE MEDICAL RESOURCE
SOFTWARE FOR THE TERM OF MARCH 1, 2022, THROUGH FEBRUARY 28, 2027,
IN AN AMOUNT NOT TO EXCEED \$491,593**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on February 25, 2022, the County entered into an agreement with UpToDate, Inc. for a subscription to the UpToDate Anywhere software which provides San Mateo Medical Center (SMMC) a point-of-care medical resource software for the term of March 1, 2022, through February 28, 2027, in an amount not to exceed \$491,593; and

WHEREAS, UpToDate, Inc. is the sole provider of the subscription to UpToDate Anywhere, which consists of the UpToDate online database, software, and user documentation and this subscription is needed to ensure regulatory compliance; and

WHEREAS, SMMC is requesting this Board waive the Request for Proposals process and ratify the agreement to allow Contractor to continue to provide these services; and

WHEREAS, this Board has been presented with a form of such agreement, has examined and approved it as both form and content, and desires to ratify and authorize it.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of the Board of Supervisors be and is hereby authorized and directed to execute said agreement for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Chief of San Mateo County Health or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate) and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
