WHEREAS, on December 11, 2024, the County and the San Mateo County

Dave Pine; and

WHEREAS, event costs, including food, refreshments, and other goods and services, were covered by donations to the San Mateo County Event Center and the County provided space at 500 County Center; and

WHEREAS, on May 15, 2025, the County and the San Mateo County Historical Association hosted a community event celebrating the 169th Anniversary of San Mateo County and a dedication ceremony for 500 County Center; and

WHEREAS, event costs, including food, refreshments, audio-visual, seating, printed material, and logistical event support, were covered by donations to the San Mateo County Historical Association and the County provided space at 500 County Center; and

WHEREAS, donations to be acknowledged by the Board for the events totaling \$33,434 were received by community partners, in the amounts and from the sources set forth in the table included in the Board transmittal accompanying this resolution; and

WHEREAS, pursuant to County Administrative Memorandum B-3, "[r]eceipt of each gift or bequest having a value of more than \$2,500 [] shall be acknowledged in writing by the [County] department head and referred to the Board of Supervisors for acceptance or rejection;" and

WHEREAS, although donations for the two events were not made directly to the County of San Mateo and are not therefore strictly considered gifts to the County requiring Board acceptance, the County did play a significant role in hosting the events and derived benefit from them.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors hereby acknowledges donations in support of the events on December 11, 2024 and May 15, 2025 in the total amount of \$33,434.
