**RESOLUTION:**

**A) ADOPTING PLANS AND SPECIFICATIONS, INCLUDING CONFORMANCE WITH PREVAILING WAGE SCALE REQUIREMENTS FOR THE RECONSTRUCTION OF 8<sup>TH</sup> AVENUE FROM MIDDLEFIELD ROAD TO EDISON WAY, 16<sup>TH</sup> AVENUE FROM END TO 772 16<sup>TH</sup> AVENUE, AND INSTALLATION OF VALLEY GUTTERS ON FAIR OAKS AVENUE FROM 15<sup>TH</sup> AVENUE TO 16<sup>TH</sup> AVENUE IN THE NORTH FAIR OAKS AREA (PROJECT); AND B) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO CALL FOR SEALED PROPOSALS TO BE RECEIVED BY THURSDAY, JUNE 13, 2024 AT 2:30 P.M. IN THE OFFICE OF THE COUNTY EXECUTIVE OFFICER/CLERK OF THE BOARD OF SUPERVISORS; AND C) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO EXTEND THE CALL FOR BIDS AND BID OPENING UP TO SIXTY (60) CALENDAR DAYS BEYOND THE TIME AND DATE ORIGINALLY SET FORTH BY THE BOARD OF SUPERVISORS**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, this Board of Supervisors did, on April 23, 2024, adopt Resolution No. 080306, which resolution adopted the plans and specifications (the “Plans and Specifications”), including conformance with prevailing wage scale requirements and called for sealed proposals to be received by May 9, 2024 at 2:00pm for the Reconstruction of 8<sup>th</sup> Avenue from Middlefield Road to Edison Way, 16<sup>th</sup> Avenue from End to 772 16<sup>th</sup> Avenue, and Installation of Valley Gutters on Fair Oaks Avenue from 15<sup>th</sup> Avenue to 16<sup>th</sup> Avenue in the North Fair Oaks Area Project (Project); and

**WHEREAS**, no bids were received on Thursday, May 9, 2024; and

**WHEREAS**, the plans and specifications adopted by this Board by Resolution No. 080306 have been revised relative to construction schedule requirements, are dated May 17, 2024, have been approved by the Director of Public Works for the Reconstruction of 8<sup>th</sup> and 16<sup>th</sup> Avenues and Installation of Valley Gutters on Fair Oaks Avenue in the North Fair Oaks Area (Project), and said plans and specifications have been filed in the office of the Director of Public Works (the “plans and specifications”); and

**WHEREAS**, the plans and specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by the Department of Industrial Relations, in the locality in which said work is to be performed for each type of worker needed to execute the contract; and

**WHEREAS**, the public’s best interest will be served by including the Fair Oaks Sewer Maintenance District sewer upgrade work along 8<sup>th</sup> Avenue and 16<sup>th</sup> Avenue in this Project.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** as follows:

1. The plans and specifications dated May 17, 2024, for the aforesaid Project, which are on file in the office of the Director of Public Works, and to which reference is hereby made for further particulars, are hereby approved, and

adopted as the plans and specifications to be adhered to in letting and performing the work under a contract for the improvements described therein.

2. Said specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by the Department of Industrial Relations, in the locality in which said work is to be performed for each type of worker needed to execute the contract.
3. The Department of Public Works is authorized and directed to issue a call for sealed bids and to set the bid opening date and time on Thursday, June 13, 2024 at 2:30 p.m. in the office of the County Executive Officer/Clerk of the Board of Supervisors in the Hall of Justice, Redwood City, California. Said bids will be received by the Clerk of the Board of Supervisors and then transmitted to the County Executive's Office in said Hall of Justice and be publicly opened and declared.
4. The Director of Public Works is authorized to extend the call for bids and bid opening up to sixty (60) calendar days beyond the time and date originally set forth by the Board of Supervisors.
5. The Department of Public Works is further directed to cause the Notice inviting sealed bids to be published for two (2) times in a weekly local newspaper of general circulation, published in the County, and obtain an affidavit of said publication, a copy of which shall be placed on file with the Department of Public Works.
