

**AMENDMENT NO. 2 TO MASTER AGREEMENT**  
**BETWEEN THE COUNTY OF SAN MATEO AND**  
**CAREFUSION SOLUTIONS, LLC**

THIS AMENDMENT (“Amendment No. 2”) TO THE MASTER AGREEMENT dated September 10, 2013 (“Agreement”) is entered into this \_\_\_\_ day of \_\_\_\_\_, 2019 (“Effective Date”) by and between the COUNTY OF SAN MATEO, hereinafter called "County", and CAREFUSION SOLUTIONS, LLC, hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof; and

WHEREAS, on September 10, 2013, the Parties entered into a master agreement (“Master Agreement”) governing the execution of Customer Orders for BD Pyxis™ MedStation™ 4000 system and BD Pyxis™ Anesthesia Station 4000 products (collectively, “Med 4000 Products”) subject to a term of five (5) years, terminating on September 10, 2018; and

WHEREAS, on September 10, 2013, County intended that any Customer Order for Med 4000 Products should be and deemed an amendment to the Master Agreement (hereafter, “Master Amendment”) notwithstanding **Section 1.1** of the Master Agreement stating, in effect, that each Customer Order is a separate agreement between the Parties; and

WHEREAS, subsequent to the execution of the Master Agreement, the Parties entered into Master Amendments for the upgrade of BD Pyxis™ MedStation™ 3500 and BD Pyxis™ Anesthesia 3500 Station products (“Med 3500 Products”) to Med 4000 Products as set forth in **Exhibit A**, attached hereto, characterized by contracting irregularities but intended by the Parties to be memorialized in Master Amendments subject to the same Rental and Support Terms of five (5) years, beginning on the Term Begin Date of March 1, 2014; and

WHEREAS, in consideration of County’s acquisition of Med 3500 Products, CareFusion provided a Virtual Test System, subject to a five (5)-year term expiring on November 1, 2018; however, the Virtual Test System is still being used by Customer in accordance with CareFusion’s business practice of providing such test system as part of Customer Orders for the upgrade of Med 3500 Products to Med 4000 Products; and

WHEREAS, on January 10, 2017, the Parties entered into a Master Amendment memorializing: (i) County’s acquisition of additional Med 4000 Products and Services, subject to Rental and Support Terms of twenty-six months (26) months (a date intended by the Parties to be coterminous with the initial terms end dates of the Pyxis Products and Services under all other

Master Amendments); as well as (ii) County's increase of the maximum payable amount under the Master Agreement to One Million Two Hundred Twenty Thousand Dollars (\$1,220,000.00); and

WHEREAS, the Parties now wish to amend the Master Agreement to memorialize (i) the correct form of Customer Orders attached to Master Amendments; (ii) the extension of the term of the Master Agreement; (iii) the extension of the Rental and Support Terms of the Pyxis Products under the Master Amendments as set forth in **Schedule 1**; (iv) the acquisition of additional Med 4000 Products as set forth in **Schedule 2**; and (v) the increase County's "Not To Exceed Amount" by \$300,000 applicable in relation to all Master Amendments executed by the Parties under the Master Agreement as of the Effective Date; and

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS.**

- 1. Premises above.** The premises set forth above are hereby incorporated into this Amendment No. 2 as is fully set forth herein. Capitalized terms not defined herein shall have the meanings ascribed in the Master Agreement.
- 2. Modifications to Master Agreement.**

**2.1 Section 1.1 of the Master Agreement, "Customer Orders."** Delete the title and text of this subsection and replace with the following.

- 1.1 Master Amendments; Not to Exceed Amount.** The Parties may enter into various transactions for hardware ("Equipment"), software licenses, accessories, and other products (collectively, "Products") and/or services ("Services"), which will be provided pursuant to these General Terms and Conditions, as supplemented by Schedules for specific Products and/or Services. CareFusion will set forth the Products and/or Services for each transaction in a Customer Order, each of which shall be: (i) attached to an amendment to this Master Agreement (each, a "Master Amendment") and (ii) deemed a part of this Master Agreement.

Notwithstanding the foregoing, in no event shall County's total fiscal obligation under the Master Amendments collectively exceed ONE MILLION FIVE HUNDRED TWENTY THOUSAND DOLLARS (\$1,520,000.00) (the "Not to Exceed Amount").

**2.2 Section 6.2, Term; Termination without Cause.** The text of **Subsection 6.2** of the Master Agreement (**Term; Termination Without Cause**) is hereby deleted in its entirety and replaced with the following:

**6.2 Term; Termination without Cause.** This Master Agreement will have a term of seventy-two (72) months ("Master Term"), starting on the Effective Date. The Master Agreement will terminate at the end of the Master Term ("Master Termination Date"), provided that any Master Amendments with Rental and Support Term remaining shall

continue to be governed by this Master Agreement for the remainder of that term. No new Master Amendment may be entered into after the Master Termination Date, unless pursuant to a new Master Agreement or an amendment to this Master Agreement signed by both Parties.

Notwithstanding the foregoing, either Party may terminate this Master Agreement upon thirty (30) days' written notice if there are no payments due and no other obligations yet to be performed under any Master Amendment.

**3. Contracting Irregularities; Corrected Master Amendments.** The Parties understand and agree that, by way of signature of this Amendment No. 2 by duly represented authorized representatives of each Party, any contracting irregularities related to Customer Order Numbers 2000004474 and 2000004484 and 2000004490 attached hereto as **Exhibit A** ("Corrected Master Amendments"), including improper execution of all such Master Amendments, are hereby waived pursuant to the terms of this Amendment. The Parties understand and agree that the Pyxis Products set forth in the Corrected Master Amendments shall be included in **Schedule 1** intended to include Extended Term Products as such term is defined in **Section 4**, below.

**4. Extended Rental and Support Terms.** The Rental and Support Terms applicable to the Pyxis Products set forth in **Schedule 1** ("Extended Term Products") are hereby extended until February 29, 2020 ("Extended Term"), subject to the terms and conditions set forth herein.

**4.1** During the Extended Term, the Monthly Support Fees payable by County for the Extended Term Products will be as set forth under the "Monthly Support Fee" column of **Schedule 1**, subject to any interim Monthly Support Fee increases pursuant to **Section 2** of the Support Terms Schedule of the Master Agreement (*Payment of Monthly Support Fees*). CareFusion may increase the Monthly Support Fee during the Extended Term once every twelve (12) months by no more than the Consumer Price Index for Medical plus three percent (3%), provided that: (i) County receives at least ninety (90) days' written notice; and (ii) any such increase will be effective as of the anniversary date of the Extended Term.

**4.2** Extended Term Products will be subject to any then-applicable changes to the support program as generally commercially released by CareFusion. In accordance with **Section 4** of the Support Term Schedule included in the Master Agreement (*Properly Performing*), CareFusion's repair/replace obligation will be subject to commercially reasonable efforts, including, without limitation, the use of refurbished parts to keep the Extended Term Products Properly Performing. If a refurbished part is no longer available or CareFusion is unable to repair or restore the functionality of an Extended Term Product, then (i) CareFusion shall provide County with prompt notice of termination of its repair or service obligation with respect to that Extended Term Product ("Terminated Service Product"); (ii) CareFusion shall have no further repair or service obligation with respect to the Terminated Service Product; and (iii) County shall have no further obligation to pay the Monthly Support Fee for the Terminated Service Product effective as of the first day of the month following CareFusion's notice to County of the Terminated Service Product.

4.3 Notwithstanding any term or condition of the Master Agreement to the contrary, if any software or database owned by a third party that is embedded into or used in connection with an Extended Term Product reaches an end-of-life status (“End of Life Software”) during the Extended Term, CareFusion reserves the right to pass through to County any additional costs, including, but not limited to, licensing and support related costs imposed by the third-party vendor for the End of Life Software.

4.4 At the conclusion of the Extended Term, any further extension of the Rental Term and Support Term will be in accordance with the terms of the Master Agreement.

**5. Additional Pyxis Products and Services.** The Med 4000 Products set forth in **Schedule 2** are hereby added to this Master Agreement.

6. All other terms and conditions of the Master Agreement dated September 10, 2013, between the County and Contractor, and any amendments, shall remain in full force and effect unless specifically amended herein.
