RESOLUTION REJECTING ALL BIDS RECEIVED FOR THE QUARRY PARK FIRE ROAD EXTENSION PROJECT

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, this Board of Supervisors did, on May 9, 2023, adopt Resolution No. 079603, which resolution adopted the plans and specifications (the "Plans and Specifications"), dated May 5, 2023 including conformance with prevailing wage scale requirements and called for sealed proposals for the Quarry Park Fire Road Extension Project (Project); and

WHEREAS, the Engineer's Estimate for construction of the Project was \$1,000,000; and

WHEREAS, the Deputy Clerk of this Board of Supervisors did, in public on June 1, 2023, at 2:30 p.m., open and examine all sealed bids that were received in the specified time for the doing of the work referred to in said Plans and Specifications; and

WHEREAS, this Board of Supervisors has caused an analysis of said bids to be made by the Director of Public Works of the County of San Mateo, and has, in open session, fully reviewed and considered said sealed proposals and analysis thereof; and

WHEREAS, the two bids that were received were considerably higher than the Engineer's Estimate of \$1,000,000; and

WHEREAS, the Director of Public Works recommends that all bids received be rejected and the Project be re-advertised for bids at a later time.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

- 1. It is to the best interest of the County of San Mateo to reject all bids for the Quarry Park Fire Road Extension Project and the Board of Supervisors hereby rejects all bids received on June 1, 2023 for the Quarry Park Fire Road Extension Project and the Director of Public Works, or designee, shall inform all the bidders on this Project of this determination.
- 2. The Director of Public Works is hereby authorized and directed to proceed with re-advertising the Project for bids at a later time and to report to this Board with recommendations on awarding a contract to the lowest responsible bidding for said Quarry Park Fire Road Extension Project once bids are received and confirmed.
