RESOLUTION AUTHORIZING AGREEMENTS WITH JAHINI LLC, DBA REDWOOD CREEK INN IN AN AMOUNT NOT TO EXCEED \$200,000 AND V & H HOSPITALITY, INC., FOR HOTEL SERVICES, FOR THE TERM OF JULY 1, 2024 THROUGH JUNE 30, 2025, IN AN AMOUNT NOT TO EXCEED \$200,000

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California,

WHEREAS, Aging and Adult Services (AAS) requires hotel services for clients experiencing housing instability and in emergency situations; and

WHEREAS, the need for hotel services rose when the County began to receive Home Safe funding from the State of California in 2021; and

WHEREAS, AAS conducted a Request for Proposals in March 2024 and V & H Hospitality, Inc. and Jahini LLC, DBA Redwood Creek Inn were selected as hotel service providers.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Chief of San Mateo County Health or the Chief's designee is authorized and directed to prepare an agreement with V & H Hospitality, Inc. for a total amount not to exceed \$200,000 and an agreement with Jahini LLC, DBA Redwood Creek Inn for a total amount not to exceed \$200,000, both for the term of July 1, 2024, to June 30, 2025.

BE IT FURTHER RESOLVED that the President of this Board of Supervisors be and is hereby authorized and directed to execute said agreement for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Chief of San Mateo County Health or the Chief's designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate) and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
