WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement on January 28, 2020 for Contractor's temperature equipment installation and monitoring services; and

WHEREAS, the parties wish to amend the Agreement to extend the Term of the Agreement by three years and to increase the County's total fiscal obligation by \$120,894.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3, Payments, of the Agreement is deleted in its entirety and replaced to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed \$326,654. In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contracttermination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.

2. Section 4, Term, of the Agreement is deleted in its entirety and replaced to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from January 28,2020, through March 31, 2026.

3. Exhibit B is hereby amended by adding the following Contractor's fee schedule effective for the period of 4/1/2023 to 3/31/2026:
