RESOLUTION AUTHORIZING A FOURTH AMENDMENT TO THE AGREEMENT WITH SCOTT OESTERLING MD, INC., EXTENDING THE TERM OF THE AGREEMENT BY TWO MONTHS THROUGH MAY 31, 2025, AND INCREASING THE MAXIMUM PAYABLE AMOUNT OF THE AGREEMENT PROPORTIONATELY BY \$516,522.34 TO AN AMOUNT NOT TO EXCEED \$10,341,305.84

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on November 16, 2021 the County and Scott Oesterling MD, Inc.

("the Oesterling Group") entered into an agreement for obstetrics and gynecology

services in an amount not to exceed \$9,050,000 ("the Agreement"); and

WHEREAS, the parties entered into a First Amendment to the Agreement on

December 6, 2021 to update the List of Approved Providers; and

WHEREAS, the parties entered into a Second Amendment to the Agreement on April 1, 2022 to further update the List of Approved Providers; and

WHEREAS, on December 10, 2024 the parties entered into a Third

Amendment to the Agreement to assign the providers' right to bill and collect for their professional medical services to the County, extend the term of the agreement from January 1, 2022 through March 31, 2025, increase the monthly payment to the group by 3% effective January 1, 2025 through March 31, 2025 from \$250,739 per month to \$258,261.17 per month, increase the Agreement's "not to exceed" amount from \$9,050,000 to \$9,824,783.50, and again update the List of Approved Providers; and

WHEREAS, the parties desire to enter into a Fourth Amendment to the Agreement to extend its term by two months for a term of January 1, 2022 through May 31, 2025, and increase the "not to exceed" amount by two additional monthly payments of \$258,261.17, from \$9,824,783.50 to \$10,341,305.84, for the purpose of allowing South County Community Health Center, Inc. dba Ravenswood Family Health Network a California not for profit public benefit corporation, and Lucile Salter Packard Children's Hospital at Stanford time to review a proposed definitive agreement that integrates care for low-income OB-GYN patients throughout the County

WHEREAS, this Board has been presented with a form of such an amendment, has examined and approved it as both form and content, and desires to enter into it.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

President of the Board of Supervisors be and is hereby authorized and directed to execute said Fourth Amendment to the Agreement for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Chief of San Mateo County Health or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate) and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
