WHEREAS, the Commission proudly includes two County representatives to the esteemed California Senior Legislature, a Youth Commissioner, and a member of the Board of Supervisors, or their representative, ensuring a comprehensive and multifaceted approach to addressing the challenges faced by older adults in the county. The Commission's leadership comprises three elected officers, namely the Chairperson, 1st Vice-Chair, and 2nd Vice-Chair, who bring forth their invaluable leadership and expertise to create a positive impact on the lives of older adults in San Mateo County; and

WHEREAS, Commissioner Cherie Querol Moreno has faithfully served as a member of the San Mateo County Commission on Aging, demonstrating unwavering commitment, professionalism, and passion in her efforts to promote the well-being and quality of life of older adults in our community;

NOW, THEREFORE, BE IT PROCLAIMED that the San Mateo County Commission on Aging, in recognition of Commissioner Cherie Querol Moreno's exemplary service, extends its deepest appreciation and gratitude for her invaluable contributions, tireless efforts, and dedication in advocating for the needs of older adults in San Mateo County.
