**PURPOSE FOR AMENDMENT:** The purpose of the Grant amendment is to: Increase the Grant amount for Fiscal Year (FY) 2021 (07/01/2021-06/30/2022); to allow the Grantee to continue performing more of the same services as identified in Exhibit A and to reimburse the Grantee accordingly.

**AMENDED GRANT AMOUNT:** This amendment is to increase the grant for **FY 2021** by **\$69,813** and is amended to read: The maximum amount payable under this Grant shall not exceed ~~Eight Hundred Forty Eight Thousand, Eight Hundred Fifty Dollars (\$848,850)~~ **Nine Hundred Eighteen Thousand, Six Hundred Sixty-Three Dollars (\$918,663)**.
