# What are Boards and Commissions?

**Mission:** To advise the County and the Board of Supervisors in decision-making, service delivery, spending priorities, and program direction.

Boards and Commissions are groups of residents who address a specific area of interest with the expertise and the lived experience they possess. Some have advisory capacity, and some make legally binding decisions.

Boards and Commissions do not make policy decisions, manage or direct programs, commit County resources, or take an official position that has not been approved by the Board of Supervisors.

# Requirements for Service

- **Living in San Mateo County is the sole requirement for service** on most County Boards and Commissions.
- Certain Boards and Commissions may have additional requirements.
- County employees are permitted to serve, provided there is no conflict of interest.

# 2025 Membership Snapshot

- In May 2025, the Intergovernmental & Public Affairs Unit worked with the Office of Racial and Social Justice to conduct an unscientific survey of the demographic makeup of the “core” advisory boards and commissions
- Questions included: age, race(s)/ethnicity, education level, gender identity, sexual orientation, disability, household income, rent/own, employment status, supervisorial district, citizenship status, and native language
- Board and Commission member responses were anonymous
- 175 responses were submitted

# 2025 Membership Snapshot

When compared with the latest ACS/Census Data, the survey revealed the following notable takeaways about Board and Commission Members:

- Older, more likely to be white, more educated, more likely to own a home, more likely to be born in the U.S., and more likely to consider English their native language than the county population as a whole
- More likely to identify as Female than the population at large (58.29% for commissioners vs. 50.01% for the county population)
- More likely to identify as having a disability than the population at large (18.29% for commissioners vs. 10.00% for the county population)
- Have higher median incomes than the population at large (\$180,000-\$199,999 for commissioners vs. \$151,485 for the county population)
- District Count: D3=26%, D2=21%, D4=16%, D1=14%, and D5=13%; 10% of respondents indicated other or declined to state

# Brown Act Changes

## Senate Bill 707 (Chapter 327, Statutes of 2025)

- Effective January 1, 2026
- Authorizes local agencies to permit remote attendance at meetings of “eligible subsidiary bodies” (non-decision advisory bodies) when doing so would enhance public access and promote the attraction, retention, and diversity of the members of the eligible subsidiary bodies
- The Board of Supervisors must take action, every six months, to give permission (may be on consent) to its advisory commissions to hold fully online meetings
- Some boards and commissions are ineligible for various reasons (e.g., not purely advisory, but decision-making, primary subject matter jurisdiction, or consist entirely of elected officials)
- The County must continue to provide a physical location for the public to make public comment, even for a fully online meeting, and provide at least one staff member present in the room
