RESOLUTION: A) CONSOLIDATING THE PRESIDENTIAL GENERAL ELECTION, TO BE HELD ON TUESDAY, NOVEMBER 5, 2024, WITH ELECTIONS CALLED BY LOCAL GOVERNING BODIES THAT HAVE REQUESTED THEIR RESPECTIVE ELECTIONS BE CONSOLIDATED WITH SAID GENERAL ELECTION; AND B) AUTHORIZING THE COUNTY'S CHIEF ELECTIONS OFFICER TO PROVIDE SPECIFIED ELECTION SERVICES AND SUPPLIES IN CONJUNCTION THEREWITH

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Election Code Sections 10400 through 10418 authorize the Board to order the consolidation of elections that are called to be held on the same day in or within the same territory upon the order of the governing body or bodies calling the elections and, if ordered, the consolidated election shall be held in all respects as if it were one election, with the returns being canvassed by the County's Chief Elections Officer; and

WHEREAS, absent other arrangements or applicable law, the costs of any school district election shall be borne by the school district holding the election pursuant to Education Code Section 5421, and any city or district shall reimburse the County in full for the services performed by the County's Chief Elections Officer in accordance with Division 10 of the Elections Code; and

WHEREAS, the following school districts are required by law to hold regularlyscheduled governing board elections, have notified the County's Chief Elections Officer of the number of seats to be elected and the relevant policies for breaking a tie vote, and are requesting an election as more candidates have filed to run for office in the named jurisdictions than there are seats available: San Mateo County Board of Education; Bayshore Elementary School District; Belmont-Redwood Shores School District; Brisbane School District; Burlingame School District; Cabrillo Unified School District; Hillsborough City School District; Jefferson Elementary School District; Jefferson Union High School District; La Honda-Pescadero Unified School District; Las Lomitas Elementary School District; Menlo Park City School District; Millbrae Elementary School District; Pacifica School District; Portola Valley Elementary School District; Ravenswood City School District; Redwood City School District; San Bruno Park School District; San Carlos School District; San Mateo County Community College District; San Mateo-Foster City School District; San Mateo Union High School District; Sequoia Union High School District; South San Francisco Unified School District; and Woodside Elementary School District; and

WHEREAS, the following districts are required by law to hold regularly-scheduled governing board elections, have notified the County's Chief Elections Officer of the number of seats to be elected and the relevant policies for breaking a tie vote, and are requesting an election as more candidates have filed to run for office in the named jurisdictions than there are seats available: Bayshore Sanitary District; Broadmoor Police Protection District; Coastside County Water District; Coastside Fire Protection District; Colma Fire Protection District; East Palo Alto Sanitary District; Granada Community Services District; Highlands Recreation District; Ladera Recreation District; Menlo Park

Fire Protection District; Midpeninsula Regional Open Space District; Mid-Peninsula Water District; Montara Water and Sanitary District; North Coast County Water District; Peninsula Health Care District; San Mateo County Harbor District; Sequoia Healthcare District; West Bay Sanitary District; Westborough Water District; Woodside Fire Protection District; and

WHEREAS, the following advisory councils are required by law to hold regularly-scheduled governing board elections, have notified the County's Chief Elections Officer of the number of seats to be elected and the relevant policies for breaking a tie vote, and are requesting an election: Pescadero Municipal Advisory Council and Midcoast Community Council; and

WHEREAS, the governing board of the Bayshore Elementary School District adopted Resolution No. 23-04 giving notice of an election to be held on November 5, 2024 for the purpose of submitting a bond measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the governing board of the Belmont-Redwood Shores School District adopted Resolution No. 2023/24-17 giving notice of an election to be held on November 5, 2024 for the purpose of submitting a bond measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the governing board of the Burlingame School District adopted Resolution 2024-2025-1 giving notice of an election to be held on November 5, 2024 for

the purpose of submitting a parcel tax measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the governing board of the Cabrillo Unified School District adopted Resolution Nos. 09-2024 and 10-2024 giving notice of an election to be held on November 5, 2024 for the purpose of submitting a bond measure and parcel tax measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the governing board of the Jefferson Union High School District adopted Resolution No. 2023-2024/18 giving notice of an election to be held on November 5, 2024 for the purpose of submitting a parcel tax measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the governing board of the Menlo Park City School District adopted Resolution No. 23.24.21 giving notice of an election to be held on November 5, 2024 for the purpose of submitting a bond measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the governing board of the Millbrae Elementary School District adopted Resolution No. 23-24-20 giving notice of an election to be held on November 5, 2024 for the purpose of submitting a bond measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the governing board of the Pacifica School District adopted Resolution No. 2024-06-26-A giving notice of an election to be held on November 5, 2024 for the purpose of submitting a parcel tax measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the governing board of the Ravenswood City School District adopted Resolution No. SY24-31 giving notice of an election to be held on November 5, 2024 for the purpose of submitting a parcel tax measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the governing board of the San Bruno Park School District adopted Resolution Nos. 24-06-02 and 24-06-03 giving notice of an election to be held on November 5, 2024 for the purpose of submitting a parcel tax measure and term limits measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the governing board of the Woodside Elementary School District adopted Resolution No. 2024-23 giving notice of an election to be held on November 5, 2024 for the purpose of submitting a parcel tax measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the Town of Atherton has adopted Resolution No. 24-12 giving notice of an election to be held on November 5, 2024 for the purpose of electing two city council members for a term of four years each and requesting the

County's Chief Elections Officer to render specified election services to the Town therefor; and

WHEREAS, the City Council of the City of Belmont has adopted Resolution Nos. 2024-49 and 2024-57, giving notice of an election to be held on November 5, 2024 for the purpose of electing two city council members for a term of four years each, electing one mayor to a two year term, submitting to Belmont voters a business license tax measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, the City Council of the City of Brisbane has adopted Resolution No. 2024-19 giving notice of an election to be held on November 5, 2024 for the purpose of electing three city council members for a term of four years each and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, the City Council of the City of Burlingame has adopted Resolution No. 060-2024 giving notice of an election to be held on November 5, 2024 for the purpose of electing one city council members for a term of two years, electing two council members for a term of four years each and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, the City Council of the Town of Colma has adopted Resolution Nos. 2024-15 and 2024-22 giving notice of an election to be held on November 5, 2024 for the purpose of electing three city council members for a term of four years each, submitting to

Colma voters a sales tax measure, and requesting the County's Chief Elections Officer to render specified election services to the Town therefor; and

WHEREAS, the City Council of the City of Daly City has adopted Resolution No. 24-76 giving notice of an election to be held on November 5, 2024 for the purpose of electing one city council member for a term of two years, electing two city council members for a term of four years each, electing one city clerk and one city treasurer to terms of four years each, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, the City Council of the City of East Palo Alto has adopted Resolution Nos. 69-2024 and 64-2024 giving notice of an election to be held on November 5, 2024 for the purpose of electing three city council members for a term of four years each, submitting to East Palo Alto voters a citizen initiative to amend a gross receipts tax ordinance, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, the City Council of Foster City has adopted Resolution Nos. 2024-53 and 2024-73 giving notice of an election to be held on November 5, 2024 for the purpose of electing three city council members for a term of four years each, submitting to Foster City voters a measure amending an existing business license tax ordinance, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, the City Council of the City of Half Moon Bay has adopted Resolution Nos. C-2024-23 and C-2024-52 giving notice of an election to be held on November 5,

2024 for the purpose of electing two city council members for a term of four years each, submitting to Half Moon Bay voters a sales tax measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, the City Council of the Town of Hillsborough has adopted Resolution No. 24-29 giving notice of an election to be held on November 5, 2024 for the purpose of electing three city council members for a term of four years each and requesting the County's Chief Elections Officer to render specified election services to the Town therefor; and

WHEREAS, the City Council of the City of Menlo Park has adopted Resolution

Nos. 6910 and 6919 giving notice of an election to be held on November 5, 2024 for the

purpose of electing two city council members for a term of four years each, submitting to

Menlo Park voters a measure increasing an existing transient occupancy tax, and

requesting the County's Chief Elections Officer to render specified election services to the

City therefor; and

WHEREAS, the City Council of the City of Millbrae has adopted Resolution Nos.

24-48 and 24-58 giving notice of an election to be held on November 5, 2024 for the purpose of electing three city council members for a term of four years each, submitting to Millbrae voters a term limit measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, the City Council of the City of Pacifica has adopted Resolution Nos. 51-2024 and 68-2024 giving notice of an election to be held on November 5, 2024 for the purpose of electing two city council members for a term of four years each, submitting to

Pacifica voters a measure increasing an existing transient occupancy tax, and requesting the County's Chief Elections Officer to render specified election services to the City therefor: and

WHEREAS, the Town Council of the Town of Portola Valley has adopted Resolution No. 2943-2024 giving notice of an election to be held on November 5, 2024 for the purpose of electing two town council members for a term of four years each and requesting the County's Chief Elections Officer to render specified election services to the Town therefor; and

WHEREAS, the City Council of Redwood City has adopted Resolution Nos. 16220 and 16234 giving notice of an election to be held on November 5, 2024 for the purpose of electing four city council members for a term of four years each, submitting to Redwood City voters a business license tax measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, the City Council of the City of San Bruno has adopted Resolution Nos. 2024-39 and 2024-66 giving notice of an election to be held on November 5, 2024 for the purpose of electing two city council members for a term of four years each, electing one mayor to a two year term, submitting to San Bruno voters a bond measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, the City Council of the City of San Carlos has adopted Resolution No. 2024-068 giving notice of an election to be held on November 5, 2024 for the purpose of electing two city council members for a term of four years each, electing one city treasurer

to a four year term, submitting to San Carlos voters a measure to determine if the office of the city treasurer should be appointed rather than elected, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, the City Council of the City of San Mateo has adopted Resolution Nos. 46(2024) and 63(2024) giving notice of an election to be held on November 5, 2024 for the purpose of electing two city council members for a term of four years each, submitting to San Mateo voters a measure amending the city's general plan, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, the City Council of the City of South San Francisco has adopted Resolution Nos. 99-2024 and 121-2924 giving notice of an election to be held on November 5, 2024 for the purpose of electing two city council members for a term of four years each, submitting to South San Francisco voters a measure increasing an existing business license tax, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, the Town Council of the Town of Woodside has adopted Resolution

No. 2024-7691 giving notice of an election to be held on November 5 2024 for the

purpose of electing three town council members for a term of four years each, and

requesting the County's Chief Elections Officer to render specified election services to the

Town therefor; and

WHEREAS, the County of San Mateo has adopted Resolution No. 080555 giving notice of an election to held on November 5, 2024 for the purpose of submitting to the

qualified electors of the Pescadero Municipal Advisory Council a ballot measure reducing the membership of the Council from thirteen to five members and requesting the County's Chief Elections Officer to render specified election services to the County therefor; and

WHEREAS, the Broadmoor Police Protection District has adopted Resolution No. 2024/25-01 giving notice of an election to be held on November 5, 2024 for the purpose of submitting to the qualified electors of the District a parcel tax measure and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, each of the aforementioned local governing bodies has requested that their respective elections, as described in the above findings, be consolidated with the November 5, 2024 Presidential General Election ("November 2024 General Election"); and

WHEREAS, the County's Chief Elections Officer is agreeable to providing specified election services and supplies requested and enumerated in the above findings in conjunction with the November 2024 General Election; and

WHEREAS, in consideration of the services and supplies to be provided by the County's Chief Elections Officer in conducting the elections described in the above findings, each local governing body requesting such services and supplies will, as required by law, enter into separate agreements with the County's Chief Elections Officer to outline the services to be rendered and to reimburse the County for the costs of said services and supplies.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

November 2024 General Election is hereby consolidated with the local elections described in this Resolution duly called by their respective governing bodies, and the County's Chief Elections Officer is authorized to provide specified election services and supplies in conjunction therewith.
