### RESOLUTION AUTHORIZING THE PRESIDENT OF THE BOARD OF SUPERVISORS TO EXECUTE A SECOND AMENDMENT TO THE AGREEMENT WITH SCRAM OF CALIFORNIA INC., EXTENDING THE TERM BY THREE MONTHS THROUGH SEPTEMBER 30, 2025, AND INCREASING THE AMOUNT BY \$100,000 FOR A NEW NOT-TO-EXCEED AMOUNT OF \$975,000

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Board approved an Agreement with SCRAM of California Inc. on June 14, 2022, via Resolution No. 078954, to provide global positioning system (GPS), house arrest, and continuous alcohol monitoring (CAM) services to adult and juvenile probationers and defendants in Pretrial Services to ensure compliance with the program requirements; and

WHEREAS, on December 10, 2024, the parties entered into an amendment to add \$275,000 for a new not-to-exceed amount of \$875,000; and

WHEREAS, the parties seek amend the agreement a second time to add \$100,000 for a new not-to-exceed contract amount of \$975,000 and extend the term through September 30, 2025.

# NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED, that the

President of the Board of Supervisors be and is hereby authorized and directed to execute said amendment for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED** that the Chief Probation Office, or his/her designee, is authorized to execute further amendments to the Agreement that modify the County's maximum fiscal obligation up to an additional \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term and/or services is/are within the current or revised fiscal provisions.
