HONORING THE LIFE OF / BOARD MEMBER REMARKS

Supervisor Corzo made the following remarks. "The election results of the past week have been met with a wide range of reactions and emotions. Many communities are uncertain and fearful about what lies ahead. I want everyone to know that in this moment of transition, I see them, stand with them, and I am committed to the safety, dignity, and well-being of all of our County residents. San Mateo County is home to all of us whatever our background and beliefs are. I am a daughter of immigrant family and an ally to vulnerable communities. I know how important it is to stand up to protect and serve all of our neighbors. I am here to lead, especially in times of changing and uncertainty and this moment is precisely when we need to dig deeper and work together, guided by the values that make our community resilient and I want to be clear that I believe our Board will continue to include equity, inclusion and belonging. And also to advocate for vulnerable communities, including immigrants, LGBTQ+ people, religious minorities, women, and all those who feel threatened to share. Everyone has access to the resources and opportunities and protections that we all deserve here in our home".

Supervisor Mueller shared the same sentiments shared by Supervisor Corzo. He

also mentioned that at our last Board meeting, he actually asked for a report from our County Executive on the professional work they are doing at the moment and are already taking precautions to assist our vulnerable members of our community such as the undocumented. The work has already begun.

Supervisor Slocum thanked Supervisor Corzo for sharing her remarks with the Board and the public. Supervisor Slocum provided a summary of the 9th Annual Veterans Luncheon to the Board and the public. More than 300 attended the luncheon and among them were 4 World War II veterans. The 2024 Honorees were: Enterprise of the Year - San Mateo Elks Lodge, Veteran of the Year - Bob Hoover, Patriot of the Year - Congresswoman Anna Eshoo, and Lifetime Achievement Award - Supervisor Warren Slocum.
