**RESOLUTION: A) ACCEPTING THE CERTIFICATE OF THE CHIEF ELECTIONS OFFICER AS THE STATEMENT OF THE RESULTS OF THE VOTE AS DETERMINED BY THE OFFICIAL CANVASS OF THE NOVEMBER 5, 2024 PRESIDENTIAL GENERAL ELECTION; AND B) DECLARING THE PERSONS ELECTED TO OR NOMINATED FOR CERTAIN OFFICES; AND C) DECLARING THE RESULTS OF A LOCAL BALLOT MEASURE**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that:

**WHEREAS**, the San Mateo County Chief Elections Officer has completed the official canvass of the returns of the votes cast in the Presidential General Election held in the County of San Mateo on November 5, 2024 (“Election”), has prepared in accordance with law a statement of votes polled at the Election (the “Statement of the Vote”), and has presented a certified copy of the Statement of the Vote to this Board; and

**WHEREAS**, the Chief Elections Officer will deliver a duplicate of the certified Statement of the Vote to the California Secretary of State; and

**WHEREAS**, the Chief Elections Officer has also determined that the number of persons who filed declarations of candidacy for certain offices does not exceed the number of positions available; and

**WHEREAS**, the Chief Elections Officer will deliver to each person elected a certificate of election, signed and authorized by the Chief Elections Officer; and

**WHEREAS**, pursuant to Elections Code Section 15400, the governing body of a jurisdiction—here, this Board of Supervisors—shall declare elected or nominated to each office voted on at each election under its jurisdiction the person having the highest number of votes for that office or the person who was otherwise duly elected or nominated, and shall also declare the results of each election under its jurisdiction as to each measure voted on at the election.

**NOW THEREFORE, BE IT RESOLVED AND HEREBY ORDERED** that the Deputy Clerk of the Board shall enter upon the minutes of this meeting of this Board of Supervisors said abstract or Statement of the Vote polled at the Election.

**BE IT FURTHER RESOLVED** that the Statement of the Vote polled shall be and is hereby adopted as the official vote of the Election.
