

**Second Amendment to Agreement
Between the County of San Mateo and Sutter Bay Medical Foundation, a California
nonprofit public benefit corporation dba Palo Alto Medical Foundation for Health
Care, Research and Education for Vascular Surgery Services**

THIS AMENDMENT TO THE AGREEMENT, entered into this 26 day of
August 2025, by and between the COUNTY OF SAN MATEO, hereinafter
called "County," and Sutter Bay Medical Foundation, a California nonprofit public benefit
corporation dba Palo Alto Medical Foundation for Health Care, Research and Education,
hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code Section 31000, County may contract
with independent contractors for the furnishing of such services to or for County or any
Department thereof;

WHEREAS, the parties entered into an agreement for vascular surgery services
for the term of September 1, 2022 through August 31, 2025, in an amount not to exceed
\$ 1,350,000.00 (the "Agreement"); and

WHEREAS, the parties on January 28, 2025 the parties amended the agreement
to update the contractor provider list and increase the "not to exceed" amount of the
agreement by \$200,000 to an amount not to exceed \$1,550,000.00; and

WHEREAS, the parties desire to further amend the agreement to extend the term
by three months and proportionately increase the "not to exceed" amount of the
agreement by \$ 129,167.00 with no change in compensation formula to account for the
extended term;

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS
FOLLOWS:**

1. **EXHIBIT B** (entitled **PAYMENTS**) Section IV. is amended to read as follows:

Total payment for services under this Agreement will not exceed ONE MILLION
SIX HUNDRED SEVENTY-NINE THOUSAND ONE HUNDRED SIXTY-SEVEN
DOLLARS (\$1,679,167.00).

2. Section 3.1 (entitled **Term**) of the Agreement is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement

shall be from September 1, 2022 through November 30, 2025. Each consecutive 12-month period within the term of this Agreement beginning with the first day of this term shall constitute a "Contract Year", and any period of less than a Contract Year at the end of the term shall be treated prorate for purposes of Contract Year services and compensation.

3. **EXHIBIT D** of the Agreement (entitled "CONTRACTOR PROVIDER LIST") is amended to read as follows:
