RESOLUTION AUTHORIZING THE ESTABLISHMENT OF A “NO OVERSIZED VEHICLE PARKING” ZONE ON BOTH SIDES OF CAPISTRANO ROAD IN THE UNINCORPORATED HALF MOON BAY AREA COMMENCING AT A POINT 120 FEET SOUTHERLY OF THE CENTERLINE OF HIGHWAY 1 AND EXTENDING SOUTHERLY A DISTANCE OF 1,630 FEET, MORE OR LESS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, California Vehicle Code Section 22507, et seq., and Section 7.28.070 of the San Mateo County Ordinance Code allow this Board of Supervisors to prohibit or restrict the stopping, parking or standing of vehicles by resolution or ordinance, including, but not limited to, vehicles that are six feet or more in height, or any trailer, on certain streets or highways, or portions thereof, during all or certain hours of the day; and

WHEREAS, parking is generally allowed on Capistrano Road and The Department has found vehicles frequently park or stop on the side of the street in the unpaved shoulder of the road and occasionally encroach into the paved roadway area; and

WHEREAS, the Director of Public Works has recommended that a “No Oversized Vehicle Parking” zone be established as noted herein and on Exhibit A attached hereto; and

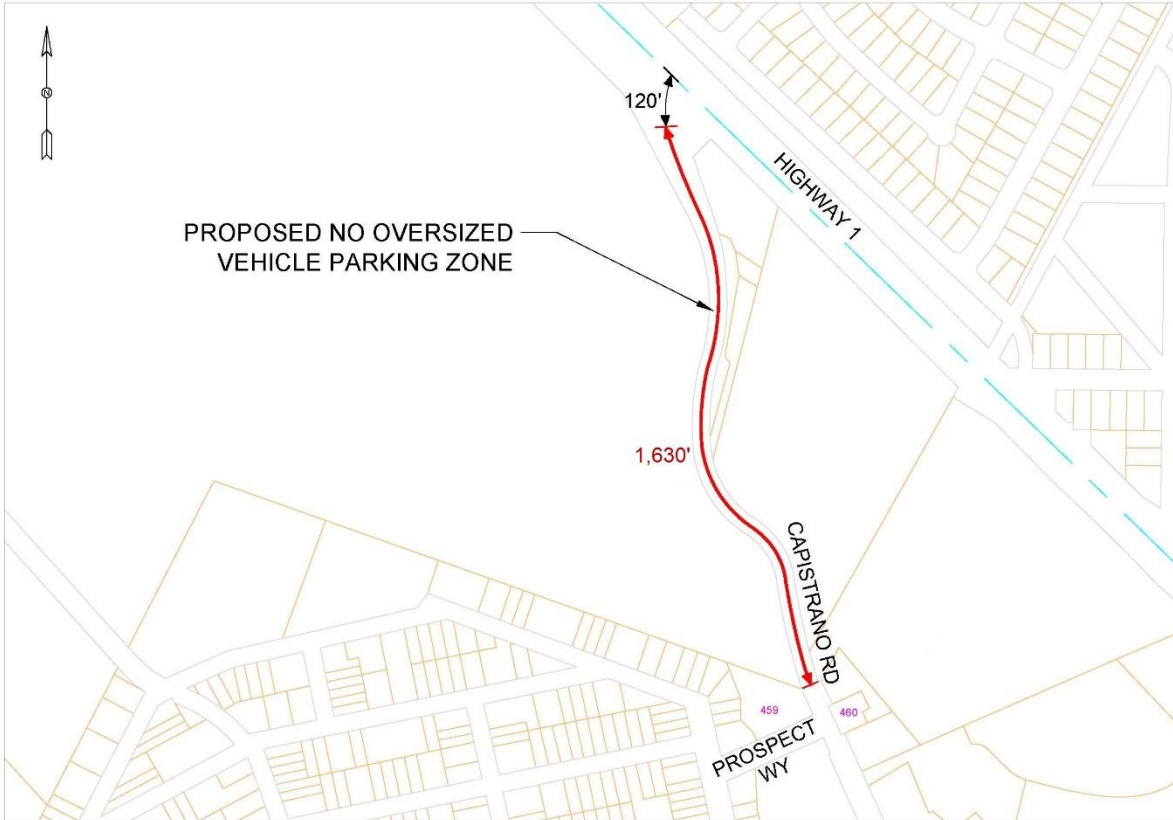
WHEREAS, this Board has reviewed and concurs with the recommendation of the Director of Public Works.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

1. A “No Oversized Vehicle Parking” zone is declared to exist on the easterly side of Capistrano Road commencing at a point 120 feet southerly of the centerline of Highway 1 and extending southerly a distance of 1,630 feet, more or less.
2. A “No Oversized Vehicle Parking” zone is declared to exist on the westerly side of Capistrano Road commencing at a point 120 feet southerly of the centerline of Highway 1 and extending southerly a distance of 1,630 feet, more or less.
3. The Department of Public Works is authorized and directed to post any necessary signs and pavement markings.
