AND**

**B) AUTHORIZING THE CHIEF OF SAN MATEO COUNTY HEALTH, OR  
DESIGNEE(S), TO ENTER INTO REVENUE GENERATING DUI PROVIDER  
AGREEMENTS AND/OR SUBSEQUENT AMENDMENTS WITH EL CENTRO DE  
LIBERTAD AND SITIKE TO PERFORM DUI PROGRAM SERVICES, EFFECTIVE  
FEBRUARY 1, 2025 UNTIL TERMINATED, WITH A REQUIREMENT FOR  
BEHAVIORAL HEALTH AND RECOVERY SERVICES (BHRSTO PROVIDE TO THE  
BOARD OF SUPERVISORS ANNUAL ASSESSMENTS OF THE PROGRAM**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, the County of San Mateo has a demonstrated a need for additional DUI programs; and

**WHEREAS**, additional DUI programs will not jeopardize the fiscal integrity of existing licensed DUI programs in this County; and

**WHEREAS**, the approval of this resolution will authorize the Chief of San Mateo County Health, or designee(s), to execute agreements and any amendments with El Centro de Libertad (El Centro) and Sitike to perform DUI Program Services, effective February 1,2025 until terminated; and

**WHEREAS**, prior to the Chief of San Mateo County Health, or designee(s), executing agreements with the contractors identified in this resolution, documentation shall be obtained and retained, all agreements shall have been reviewed and approved

by the County Attorney, Risk Management wherever applicable, and will otherwise comply with applicable County ordinances.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the Board of Supervisors recommends DUI licensure of El Centro de Libertad and Sitike.

**BE IT FURTHER DETERMINED AND ORDERED** that the Board of Supervisors authorizes the Chief of San Mateo County Health or designee(s) to enter into revenue generating agreements and any amendments with El Centro and Sitike, effective February 1, 2025 until terminated.

**BE IT FURTHER DETERMINED AND ORDERED** that Behavioral Health and Recovery Services is to provide to the Board of Supervisors annual assessments of the DUI program.

**BE IT FURTHER DETERMINED AND ORDERED** that the Chief of San Mateo County Health or designee is hereby authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.


