- A) AUTHORIZING THE COUNTY EXECUTIVE OFFICER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND THE UNITED STATES DEPARTMENT OF TRANSPORTATION FEDERAL HIGHWAY ADMINISTRATION TO IMPLEMENT THE SAFE STREETS AND ROADWAYS FOR ALL PESCADERO CREEK ROAD RURAL SAFETY PLANNING AND DEMONSTRATION PROJECT; AND**
- B) AUTHORIZING THE COUNTY EXECUTIVE OFFICER, OR DESIGNEE, TO EXECUTE AND SUBMIT APPLICABLE AMENDMENTS, WHICH MAY BE NECESSARY FOR THE COMPLETION OF THE CURRENT AND FUTURE PROJECTS**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on December 13, 2022, this Board adopted Resolution No. 079393 approving the San Mateo County Local Roadway Safety Plan (LRSP); and

WHEREAS, on August 1, 2023, this Board adopted Resolution No. 079873 approving the Road Safety Audit Report (RSA) for Pescadero Creek Road; and

WHEREAS, on May 16, 2024, the Department of Public Works applied for a SS4A grant for roadway improvements on Pescadero Creek Road in the unincorporated area of San Mateo County; and

WHEREAS, on September 5, 2024, the United States Department of Transportation awarded the County a \$480,000 Safe Streets and Roadways for All

planning and demonstration activities grant for the Pescadero Creek Road Rural Safety Planning and Demonstration Project (Project) from Stage Road to Butano Cutoff to conduct planning and outreach activities, preliminary engineering, and implement demonstration activities using nonpermanent materials on Pescadero Creek Road to implement recommendations from the LRSP and RSA; and

WHEREAS, the Project builds on the LRSP and RSA and focuses on improving transportation access for people of all ages and abilities; and

WHEREAS, the Department of Public Works will partner with a local community-based organization to ensure input received from key stakeholders, including community members.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors:

1. Authorizes the County Executive Officer, or designee, to execute an agreement between the County of San Mateo and the United States Department of Transportation Federal Highway Administration to implement the Safe Streets for All Pescadero Creek Road Rural Safety Implementation Project; and
2. Authorizes the County Executive Officer, or designee, to execute and submit applicable amendments, which may be necessary for the completion of the current and future projects.
