## **DEPARTMENT UPDATE**

San Mateo County Parks Commission April 3, 2025

## **Visitor Experience**

Visitor Data

The San Mateo County Parks Department will report visitor data to the Parks Commission on a quarterly basis; however, because visitor data is submitted to the office on the first day of the following month (submitted on April 1 for March) and the Commission meets on the first Thursday of each month, the data will be reported two months after the end of the quarter. For example, Quarter 1 data will be reported in the May Department Report.

#### **Facilities and infrastructure**

Don Horsley County Park at Tunitas Creek Beach

Construction at Don Horsley County Park at Tunitas Creek Beach continues, with work on walkways, utilities, landscaping, and interpretive features in progress. Currently, utilities companies are scheduling work on site as part of the effort to underground phone and electric lines, and there is some delay in their scheduling. It is projected that Don Horsley County Park will be open to the public in summer 2025.

## Realize Flood Park

Construction of Phase 1 of the Realize Flood Park Project continues to progress. The small multi-use sports field, tennis/pickleball courts, basketball court, sand volleyball court, and drop-in picnic areas and walking paths in the eastern segment of the park were completed, and a partial opening of the park in December provides access to these facilities. Walking paths, picnic and reservation sites, and landscaping in the western segment of the park are nearing completion, along with renovations to one of the restroom buildings. These predominantly landscaped portions of the park will remain closed until plantings have established in spring 2025.

Design efforts for the new playground at Flood Park playground continue, using the preferred project alternative known as Boulder Canyon as the direction for equipment selections and layout. The playground, which will be inclusive in design, will include a double tower with a bridge, spin zone, swing bank, double zipline, tot lot, interactive boulders and logs, and seating.

#### San Bruno Mountain Day Use Improvement Project

Construction of the new day use area restroom and open-air interpretive pavilion is scheduled to start in spring 2025 and be completed by early fall 2025. The project will reorganize the existing picnic sites into 9 groupings of 1, 2, or 4 table groupings, and 6 sites will be accessible to people of all abilities and connected with a circular pathway. The new restroom and interpretive pavilion will be located about 250 feet west of the current building and will have 4 accessible stalls and a connected covered open-air area with interpretive panels, exhibit space, and other interpretive content for connecting visitors with the park. Recent progress on the project includes securing an agreement with a paving and grading firm to conduct the pathway and picnic site surfacing upgrades. During construction,

closure of the day use area will be necessary.

## Natural Resource Management

Wildfire Hazard Reduction Projects

The natural resource management team is in planning phases for wildfire fuel reduction and forest health projects planned for implementation this summer. These projects include creation of shaded fuel break areas at Junipero Serra County Park and forest health work at Pescadero Creek County Park. Maintenance efforts to manage invasive plants and other vegetation regrowth is also being scoped and planned for previously completed fuel reduction project areas at Huddart, Wunderlich, Edgewood, and San Bruno Mountain.

## Spring wildlife monitoring

This time of year bring a variety of wildlife monitoring activities for the Natural Resource Management team, including nesting bird surveys, mission blue and bay checkerspot butterfly surveys, California red legged frog monitoring, and western snowy plover surveys.

## **Purpose:**

To support our role as advisors to the San Mateo County Board of Supervisors, this workplan should serve as a framework to:

- provide context for Commission meeting agendas, discussions with community members and partners, and subcommittee or working group structure and assignments
- align Commission's work with County and Parks Department priorities
- guide the Commission to develop policy and budget recommendations that advance the mission of San Mateo County Parks, within the available capacity of staff and other resources

#### Proposal:

Currently, the Parks Commission has three inactive subcommittees, and a list of items proposed for future meeting agendas. The table below proposes a method for re-organizing the Commission's work based on alignment with Parks Department priority areas and the Commission's overall role to advise the Board of Supervisors on parks policy and budget performance. All of the "Items for Future Agenda" are grouped into one of these priority areas.

In place of existing subcommittees, we propose the following:

- One Commissioner will lead each priority area of work: Visitor Services, Facilities & Infrastructure, Natural Resource Management
- All Commissioners will jointly work on Budget, Policy, & Performance
- The Lead Commissioner will identify:
  - 1 or 2 potential work areas to focus on for remainder of 2025, based on the suggested future agenda items.
  - A desired outcome for that work
  - Any additional stakeholders (County staff, community members, other agency partners) that may be invited to present, serve on a subcommittee, or otherwise inform the work
  - Next action steps to achieve desired outcome before November, 2025
- New Commissioners (once appointed) may elect to co-lead a priority area
