NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3 Payments, of the Agreement is amended to read as follows:

"In consideration of the services provided by Contractor in accordance with all terms, conditions and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. Contractor may request an increase in rates and fees in San Mateo County imposes additional taxes or minimum wage increase. Such increase in rates and taxes is subject to agreement by both the County and Contractor and must be approved in writing by the County. In no event shall County's total fiscal obligation under this Agreement exceed **Eight Hundred Fifty Thousand Dollars, (\$850,000)**. In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration."

**2.** Section 4, Term, of the Agreement is amended to read as follows:

"Subject to compliance with all terms and conditions, the term of this Agreement shall be from December 15, 2015 through **December 14, 2020**."

- 3. Section 17, Notices, of the Agreement is amended as follows. In the "Name/Title" provided for the County "Katy Roberts, HR Manager" is hereby deleted and replaced with "Dawn Sparks, HR Manager."
