AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND COMMERCIAL INSTALLATIONS COMPANY, INC

THIS AMENDMENT TO THE AGREEMENT, entered on this date______,
by and between the San Mateo County, hereinafter called "County," and Commercial
Installations Company, Inc., hereinafter called "Contractor";

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, on January 2, 2024, Human Services Agency entered into an Agreement with Contractor for the purpose of providing storage for surplus Pleion products and office furniture installation for a term of January 11, 2024 through January 10, 2027 and a total obligation not to exceed \$200,000, and

WHEREAS, the parties wish to amend the Agreement to increase the total obligation by \$150,000 for a new total obligation of \$350,000 and reduce the term by 11 months and 10 days for a revised term of January 11, 2024 to January 31, 2026; and

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3 – Payments of the Agreement are amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed THREE HUNDRED FIFTY THOUSAND DOLLARS (\$350,000.00). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.
