Customers that are provided with a level of service greater than the minimum level of service as shown above for garbage collection services, shall be charged the rates shown in Table 2a and Table 3 for their specific level of service.

1. The rates in Table 1a include collection for all three (3) curbside carts including: garbage cart(s), one (1) - 64-gallon recycling cart, and one (1) - 96-gallon compost cart. The rate for curbside services is based upon the size of the garbage cart. Additional residential recycling or compost carts will be subject to the service fees as listed in Table 1b below.
2. Table 1a., Minimum Level of Service Rates for 1- 4 residential dwelling units billed on the property tax bill.
3. Residential Carts that are not located within five (5) feet of the road right-of-way will incur additional service charges by Recology San Mateo County based upon the distance of the cart to the right-of-way in the road as listed in the Resolution Exhibit B (Unscheduled Service Fees).
