RESOLUTION AUTHORIZING AGREEMENTS WITH THE FOLLOWING THREE (3) PROVIDERS OF INFORMATION TECHNOLOGY (IT) CONTINGENCY STAFFING SERVICES, FOR THE TERM OF JANUARY 1, 2026 THROUGH DECEMBER 31, 2030, IN A COMBINED AGGREGATE AMOUNT NOT TO EXCEED \$2,000,000:

- A) V GROUP; AND**
- B) ELEGANT ENTERPRISE-WIDE SOLUTIONS, INC.; AND**
- C) INSPYR SOLUTIONS, LLC**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Human Services Agency's (HSA) Business Systems Group (BSG) branch provides Information Technology (IT) services to the various branches of HSA and has identified the need to have IT contingency staffing agreements available to fill vacancies where temporary staff augmentation is required due to increased work requirements or to temporarily fill obligations and positions critical to HSA's operations that may dictate the need for contingency staffing services on a short term basis while recruitments are conducted; and

WHEREAS, in April 2025, HSA released a Request for Proposals (RFP) to identify providers of IT contingency staffing services and based on the evaluation criteria selected the three proposers having received the highest evaluation scores: (1) V Group, (2) Elegant Enterprise-Wide Solutions, Inc., and (3) INSPYR Solutions, LLC; and

WHEREAS, this is presented to this Board of Supervisors for its consideration and

acceptance of agreements with (1) V Group, (2) Elegant Enterprise-Wide Solutions, Inc., and (3) INSPYR Solutions, LLC for the term of January 1, 2026 through December 31, 2030, for a combined aggregate amount not to exceed \$2,00,000; and

WHEREAS, this Board has been presented with said agreements, has examined and approved them as to both form and content and desires to enter into the amended agreement.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors be and is hereby authorized and directed to execute said agreements for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Director of the Human Services Agency or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
