RESOLUTION AUTHORIZING AN AMENDMENT TO THE DISTRICT-DISCRETIONARY MEASURE K GRANT AGREEMENT WITH SAN MATEO COUNTY HEALTH FOUNDATION, REALLOCATING FUNDS TO EMERGENCY RENTAL ASSISTANCE WITH NO CHANGE TO THE NOT-TO-EXCEED AMOUNT OF \$56,473 OR TERM, AND AUTHORIZING THE COUNTY EXECUTIVE, OR DESIGNEE, TO EXECUTE THE AMENDMENT

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on December 10, 2024, the County and San Mateo County Health Foundation ("SMCHF") entered into a Measure K Grant Agreement ("Agreement") to support Caring Hands in Health in an amount not to exceed \$56,473 for the term December 10, 2024, to July 31, 2025; and

WHEREAS, on May 14 2025, the Chief Financial Officer approved an amendment to the Agreement to extend the term to December 31, 2025; and

**WHEREAS**, the parties wish to reallocate a combined \$22,822 in funding for recuperative housing and medical needs to funding for emergency rental assistance, with no change to the not-to-exceed amount of \$56,473; and

**WHEREAS,** it is this Board's intent for the County Executive, or designee, to execute said amendment to the Agreement with SMCHF; and

**WHEREAS**, this Board has been presented with a form of the amendment to the Agreement and has examined it and approved it as to form and content and desires to enter into the amendment to the Agreement.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the Board of Supervisors authorizes the County Executive, or designee, to execute said amendment.

**BE IT FURTHER RESOLVED** that the County Executive or designee is authorized to execute amendments to the Agreement which modify the County's contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
