WHEREAS, Tygarjas Twyrles Bigstyck has served on countywide Boards representing the interests of Pacifica residents and striving to work towards the countywide goals of quality of life, sustainability and collaboration through the Peninsula Clean Energy, San Mateo County Library JPA, and the Local Agency Formation Commission; and

WHEREAS, Tygarjas Twyrles Bigstyck is recognized for his achievements, dedication and commitment by serving in public elected office and for enriching the lives of all residents.
