- A) ADOPTING THE PLANS AND SPECIFICATIONS, INCLUDING CONFORMANCE WITH FEDERAL PREVAILING WAGE SCALE REQUIREMENTS, FOR THE BRIDGE PREVENTATIVE MAINTENANCE PROGRAM FOR VARIOUS BRIDGES IN THE UNINCORPORATED AREAS OF SAN MATEO COUNTY PROJECT, WHICH INCLUDES THE FOLLOWING THREE BRIDGES: ALPINE ROAD BRIDGE, MADERA LANE BRIDGE, AND STAGE ROAD BRIDGE; AND**
- B) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO CALL FOR SEALED BIDS TO BE RECEIVED BY TUESDAY, JUNE 13, 2017 AT 2:30 P.M. IN THE OFFICE OF THE COUNTY MANAGER/CLERK OF THE BOARD OF SUPERVISORS; AND**
- C) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO EXTEND THE CALL FOR BIDS AND BID OPENING UP TO SIXTY (60) CALENDAR DAYS BEYOND THE TIME AND DATE ORIGINALLY SET FORTH BY THE BOARD OF SUPERVISORS**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the California Department of Transportation's (Caltrans) Local Assistance Bridge Preventative Maintenance Program (Program) defines a process that local agencies can follow for bridge preventative maintenance projects to be eligible for federal funding; and

WHEREAS, the Department has complied with the Program requirements and identified the bridge preventative maintenance projects to proceed with for federal funding; and

WHEREAS, on November 20, 2012, this Board adopted Resolution No. 072275, which authorized the execution of an agreement with Biggs Cardosa Associates, Inc.; and on June 2, 2015, this Board adopted Resolution No. 073835,

which authorized Amendment No. One to the Agreement for Engineering and Environmental Permitting Services for the Preventative Maintenance for Various County Bridges in Unincorporated Areas of San Mateo County Project (Project); and

WHEREAS, the Project consists of work on the Alpine Road Bridge over San Francisquito Creek, Madera Lane Bridge over El Corte de Madera Creek, and Stage Road Bridge over Pescadero Creek; and

WHEREAS, the Federal Highways Administration through Caltrans has provided Federal Bridge Preventative Maintenance Program (BPMP) Funds for engineering and environmental services for this Project and will provide funding for the construction of the Project; and

WHEREAS, Plans and Specifications, dated March 20, 2017 were prepared and approved by the Director of Public Works for the Project; and

WHEREAS, the plans and specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by the U.S. Department of Labor on federally funded projects, in the locality in which said work is to be performed for each type of worker needed to execute the contract; and

WHEREAS, this Board has considered and concurs with the recommendation of the Director of Public Works.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as

follows:

1. The plans and specifications dated March 20, 2017, for the aforesaid project are hereby approved and are adopted as the plans and specifications to be

adhered to in letting and performing the work under a contract for said improvements.

2. Said specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by the U.S. Department of Labor on federally funded projects, in the locality in which said work is to be performed for each type of worker needed to execute the contract.
3. The Department of Public Works is authorized and directed to issue a call for sealed proposals and to set the bid opening date and time on or before 2:30 p.m., Tuesday, June 13, 2017 in the office of the County Manager/Clerk of the Board of Supervisors in the Hall of Justice, Redwood City, California. Said bids will be received by the Deputy Clerk of the Board of Supervisors and then transmitted to the County Manager's Office in said Hall of Justice and be publicly opened and declared.
4. The Director of Public Works is authorized to extend the call for bids and bid opening up to sixty (60) calendar days beyond the time and date originally set forth by the Board of Supervisors.
5. The Department of Public Works is further directed to cause the Notice inviting sealed bids to be published for three (3) times in a newspaper receiving wide local circulation, published in the County, and to obtain an affidavit of said publication, a copy of which shall be placed on file with the Department of Public Works.
