**RESOLUTION AUTHORIZING AN AMENDMENT TO THE MASTER SALARY RESOLUTION 077624 TO RECLASSIFY SIX POSITIONS, SET THE SALARY FOR TWO CLASSIFICATIONS, CONVERT ONE POSITION TO CLASSIFIED VIA MEASURE D, AND ADD BACK ONE SPECIAL COMPENSATION; AND ACCEPT THE UPDATED REPORT OF BIWEEKLY SALARIES BY CLASSIFICATION**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

**WHEREAS**, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

**WHEREAS**, San Mateo County Ordinance No. 07303 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

**NOW THEREFORE, IT IS HEREBY ORDERED** that the Board of Supervisors authorizes an amendment to Master Salary Resolution 077624 as follows:

**SECTION 1:** Part 5 of the Resolution is amended as indicated:

HEALTH SYSTEM

1. One Medical Office Assistant I designated as Lead Orderly shall receive a 5.74% differential pay, in addition to all other compensation. Only one employee may be so assigned.

**SECTION 2:** Part 14 of the Resolution is amended as indicated:

ALL DEPARTMENTS

1. Salary for Item J086, Natural Resource Specialist III is set at \$43.68 to \$54.60 per hour.

ORGANIZATION 12000 COUNTY MANAGER

1. Salary for Item D230, Director, Office of Emergency Services is set at \$75.81 to \$94.79 per hour

ORGANIZATION 12600 AGRICULTURAL COMMISSIONER/SEALER

1. Item D182S, Management Analyst Series is decreased by 1 position for a new total of 0 positions.
2. Item D045, Administrative Services Manager I is increased by 1 position for a new total of 1 position.

ORGANIZATION 45100 PUBLIC WORKS - ADMIN

1. Item B048S, Resource Conservation Specialist-Unclassified Series is decreased by 1 position for a new total of 0 positions.
2. Item B217S, C/CAG Programs Specialist-Unclassified Series is increased by 1 position for a new total of 3 positions.

ORGANIZATION 45200 ROAD CONSTRUCTION AND OPERATIONS

1. Item J083S, Resource Conservation Specialist Series is decreased by 1 position for a new total of 0 positions.
2. Item J084S, Natural Resource Specialist Series is increased by 1 position for a new total of 1 position.

**ORGANIZATION 48400 UTILITIES**

1. Item J083S, Resource Conservation Specialist Series is decreased by 3 positions for a new total of 0 positions.
2. Item J084S, Natural Resource Specialist Series is increased by 2 positions for a new total of 2 positions.
3. Item J087, Senior Natural Resource Specialist is increased by 1 position for a new total of 1 position.

**ORGANIZATION 66000 SAN MATEO MEDICAL CENTER**

1. Item B107S, Social Worker/Children's Services Social Worker-Unclassified Series is decreased by 1 position for a new total of 0 positions.
2. Item B098S, Social Worker/Children's Services Social Worker Series is increased by 1 position for a new total of 10 positions.

**SECTION 3: Effective Date**

1. The change in Org 12600 is effective retroactive to November 1, 2020.
2. The changes in Org 45100, Org 45200 and 48400 are effective retroactive to June 14, 2020.
3. All other changes are effective on the first pay period following adoption.
