**RESOLUTION AUTHORIZING AN AGREEMENT WITH WEHOPE TO PROVIDE NON-
CONGREGATE HOMELESS SHELTER SERVICES FOR THE TERM OF JULY 1,
2024 THROUGH JUNE 30, 2027, WITH A TOTAL AMOUNT NOT TO EXCEED
\$5,000,000**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that;

WHEREAS, in December 2020, the County of San Mateo acquired a 52-unit building in Half Moon Bay that was formerly the Coastside Inn hotel, to provide safe temporary living accommodations and intensive on-site support services including housing-focused case management, service linkages, and facilities operations to assist adults and families who are experiencing homelessness with finding and moving into permanent housing; and

WHEREAS, on December 27, 2023, San Mateo County’s Human Services Agency issued a Request for Proposals to solicit proposals from eligible applicants to continue to provide non-congregate homeless shelter services at Coast House Shelter beginning July 1, 2024; and

WHEREAS, WeHOPE was selected to provide these services based on their experience and overall program approach; and

WHEREAS, HSA is requesting the County enter into an agreement with WeHOPE to operate Coast House Shelter, a non-congregate homeless shelter, and

provide intensive on-site support services, including 24/7 staffing of the program, housing-focused case management, service linkages, and facilities operations to assist those who are experiencing homelessness with finding and moving into permanent housing; and

WHEREAS, there has been presented to this Board of Supervisors for its consideration and acceptance an agreement, reference to which is hereby made for further particulars, whereby WeHOPE will operate and provide non-congregate homeless shelter services at the Coast House Shelter for the term of July 1, 2024, through June 30, 2027, for a total amount not to exceed \$5,000,000.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors be and is hereby authorized and directed to execute said agreement for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Director of the Human Services Agency or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in the aggregate), and/or modify the contract and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
