RFP for coding & reimbursement system services; and

WHEREAS, Solventum Health Information Systems, Inc. (Solventum) was

elevated due to the additional capabilities including advanced analyzers, cloud hosting,

clinical documentation integrity functionality, and groupers that factor in FQHC status;

and

WHEREAS, the County and Solventum, wish to enter into an agreement where Solventum will provide coding & reimbursement system services to SMMC for the term of December 7, 2024 through December 6, 2029, in an amount not to exceed \$1,500,000; and

WHEREAS, this Board has been presented with a form of such agreement, has examined and approved it as both form and content, and desires to enter into it.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

President of the Board of Supervisors be and is hereby authorized and directed to

execute said agreement for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Chief of San Mateo County Health or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate) and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
