## Third Amendment to Agreement Between the County of San Mateo and Pacific Foot Care Podiatry Group Inc. for Podiatry Services

	THIS THIRD AMENDMENT TO THE AGREEMENT, entered into this day
of	2024, by and between the COUNTY OF SAN MATEO, hereinafter
called	"County," and Pacific Foot Care Podiatry Group Inc., hereinafter called
"Cont	ractor";

## WITNESSETH:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an agreement for podiatry services on January 25, 2022 for the term of March 1, 2022 through February 28, 2025 in an amount not to exceed \$ 1,550,000 (the "Agreement"); and

WHEREAS, the parties first amended the Agreement on February 3, 2022 to change the term from March 1 2022 through February 28, 2025 to December 1, 2021 through November 30, 2024; and

WHEREAS, the amendment was consistent with the Stark Act's "set in advance" requirement because the formula for compensation was objectively determined on or before November 18, 2021; and

WHEREAS, the parties entered into a second amendment to the Agreement effective May 1, 2022 to remove Dr. Victor Lee from the Agreement, proportionately lower the FTE from 1.5 FTE to .9 FTE, proportionately reduce the RVU target from 6,720 to 3,549 and reduce the "not to exceed" amount from \$ 1,550,000 to \$950,000; and

WHEREAS, the amount payable under the Agreement must be increased by \$ 100,000.00 to accommodate the increase in services provided with no change in the Agreement's compensation formula;
