

**AMENDMENT TO AGREEMENT
BETWEEN THE COUNTY OF SAN MATEO AND
GENASYS**

THIS AMENDMENT TO THE AGREEMENT, entered into this 19th day of May 2026 by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Genasys, hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for fire evacuation planning services on June 10, 2019; and

WHEREAS, the parties amended the Agreement to include an online evacuation platform and subscription to countywide evacuation zones for a period of three years on May 19, 2020; and

WHEREAS, the parties amended the Agreement for an additional three years on October 19, 2022, extending the Agreement to May 23, 2026; and

WHEREAS, the parties wish to amend the Agreement to extend the period of performance through June 30, 2027.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

The following section of the Agreement (Sections 1 through 4) and the corresponding Exhibits referenced in those sections) are hereby amended to state as follows. Except as stated, all other terms and conditions of the Agreement not otherwise in conflict with this Amendment shall remain in full force and effect.

1. Exhibits and Attachments

The following exhibits and attachments are attached to this Agreement and incorporated into this Agreement by reference:

Exhibit A – Services, as revised and dated May 19, 2026

Exhibit B – Payments and Rates, as revised and dated May 19, 2026

2. **Services to be performed by Contractor**

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A as revised and dated May 19, 2026, Contractor shall deliver services for County in accordance with the terms, conditions and specifications set forth in this Agreement and in Exhibit A, as revised and dated on May 19, 2026.

3. **Payments**

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A as revised and dated May 19, 2026, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B as revised and dated, May 19, 2026.

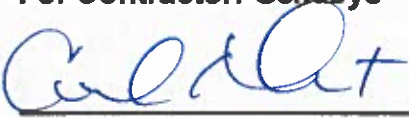
County reserves the right to withhold payment if County reasonably and in good faith determines that the quantity or quality of the work performed is unacceptable. Prior to withholding any payment under this Section, County shall meet and confer with Contractor in good faith to discuss any perceived work deficiencies and allow Contractor a reasonable time to cure any perceived defects in the services rendered. In no event shall County's total fiscal obligation under this Agreement exceed **SEVEN HUNDRED THOUSAND ONE HUNDRED SIX DOLLARS (\$744,106)**. In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.

4. **Term**

Subject to compliance with all terms and conditions, the term of this Agreement shall be from May 19, 2026 through June 30, 2027.
